SHOW RULES AND REGULATIONS

1. The Exhibition is held under the Rules of the Governing Council of the Cat Fancy, and is open to all.
2. The Show Committee is the Committee of the Club and its officers.
3. The exhibits will be received at the entrance to the Show on Saturday, November 26th, from 8 a.m. till 9.30 a.m. We regret that there will be no overnight penning. Judging will start at 10 o'clock sharp.
4. Each exhibit will be examined on arrival by the Club's Hon. Veterinary Surgeons, who will be in attendance. Cats which in their opinion are unfit for exhibition will be returned to their owners and the entry fees forfeited. No exhibit is to be penned before being examined. Any exhibitor so doing will be disqualified from competition and all fees paid forfeited. This rule will be strictly enforced.
5. Should any exhibit be disqualified by the examining Veterinary Surgeon it must leave the Hall immediately and if, in his opinion, it is desirable, all other exhibits from the same cattery, and the owner thereof, shall be debarred from attending the Show.
6. All exhibits must be accompanied by owner or representative. Exhibitors must provide their own food, sanitary pans and drinking bowls. Peat moss is provided at the Hall.
7. TALLIES will be forwarded to each exhibitor, which must be hung round the neck of each exhibit by means of a WHITE TAPE, RIBBON OR ELASTIC, which **must not be removed** until after the Best in Show Judging.
8. In case tallies do not reach the exhibitor, application should be made at the Secretary's table.
9. Entries unaccompanied by the proper amount of fees will not be accepted.
10. All exhibits must be registered with the Governing Council of the Cat Fancy. Registration Forms can be obtained from the Registrar: Mr. A. A. Towe, 6 Palmerston Road, Wimbledon, S.W.1. All registered cats which have changed ownership since registration must be transferred.
11. Neuters not competing for Premier Certificates need not be registered.
12. Exhibitors must provide SMALL WHITE blankets and SMALL sanitary pans, without distinguishing marks. The Judges are instructed to pass any pens containing decorations or distinguishing objects.
13. The Show will be open to the public from 1.30 p.m. until 5.30 p.m. Admission 2/6, children 1/-. **FREE PASSES FOR ENTRIES OVER £3.** Benching fee for each exhibit 2/-. No double pens except for litters, 3/6 each.
14. The prescribed declaration on the Club Show entry form that the exhibitor is the bona-fide owner of the exhibit, and that the exhibit is offered for exhibition subject to the Club's Show Rules and Regulations, must be signed and forwarded to the Show Manager with the entry fees. If the cat belongs to more than one person, **BOTH** must be members to compete for Cups, etc., offered by Clubs.

15. Exhibits actually received into the Show Hall cannot be withdrawn without the Committee's sanction.

16. Exhibits are received only on the condition that the Club shall not be responsible for any loss or damage to exhibits, boxes or baskets, or in any other way.

17. Exhibitors must fill in correctly, sign and deliver the Club's authorised Entry Form before any Show takes place, and they are held solely responsible for the right description of their exhibits. Entries must be accompanied by the proper amount of entry fees.

18. The Committee, on behalf of the Club, retain their exclusive right to publish catalogues of their Shows, containing information as to exhibits and names and addresses of Exhibitors.

19. The Club's Committee have the absolute right to fix and limit the number of exhibits at their Shows, and to select, accept or refuse any offers of exhibits and fees at their discretion without giving reason for so doing.

20. Should any of the Judges be prevented from fulfilling their engagements, the Committee reserve to themselves the right of appointing other Judges to fulfil their duties. The Committee reserve the right to cancel or amalgamate any of the classes.

21. An announcement in "Fur and Feather" of any alteration or addition made in the Schedule or in these "Regulations" shall be deemed sufficient notice thereof.

22. Judges are empowered to withhold any prize or Championship in any Class if the exhibits do not in their opinion possess sufficient merit.

23. Prizes will be paid from the Judges' award slips.

24. Exhibitors and visitors are strictly forbidden to interfere with or remove from its pen any exhibit other than their own without the consent of the Show Manager, under penalty of a fine not exceeding £5.

25. Any exhibit found suffering from the effects of drugs on entry or at any time during the Show will be subject to expulsion from the Show on the authority of the Veterinary Surgeon.

26. No exhibit may be removed from its pen before 5.30 unless permission for removal has been given by the Show Manager. It is urgently requested that this permission be only asked for in case of great importance, as the time for exhibition to the public is very limited indeed. **IF THIS RULE IS IGNORED, FORFEITURE OF PRIZE MONEY WILL FOLLOW.**

27. Please **SEND A STAMPED ADDRESSED ENVELOPE IF REPLIES ARE DESIRED.**

28. If an exhibit is unable to be shown owing to illness, 50% of the entry fee will be returned on receipt of a Veterinary Surgeon's certificate not less than seven days prior to the date of Show.

Breeders and owners are hereby warned by the Governing Council of the Cat Fancy against the danger of selling **WHOLE LITTERS** to **ONE** buyer, as unfortunate consequences may follow.

The Show Manager would also like to draw the attention of all exhibitors to the new rules about infection and showing which are clearly marked on the **ENTRANCE FORM**.

DEFINITIONS OF CLASSES

OPEN—Open to all.

BREEDERS—For Cats and Kittens bred by Exhibitor.

NOVICE—For Cats and Kittens that have not won a First Prize under G.C.C.F. Rules. Wins as Kittens do not disqualify in Cat Classes unless Class is for Cats or Kittens.

SENIOR—For Cats two years old or over on day of Show.

JUNIOR—For Cats under two years on day of Show.

STUD CAT.—To be judged by progeny in the Show. Both must be present.

BROOD QUEEN.—To be judged by progeny in the Show. Both must be present.

NOVICE EXHIBITOR—Owners who have never won a Money Prize at any Show under G.C. Rules.

LITTER—For three or more Kittens of the same Litter over two and under three calendar months on the day of the Show.

KITTENS—For Kittens 3 to 9 months on the day of the Show.

BRACE—For two Cats (not necessarily the same colour) belonging to the same owner.

TEAM—For three exhibits (not necessarily the same colour) belonging to the same exhibitor.

N.B.—A Team may consist of Cats, Cats and Kitten, Cat and Kittens or Kittens.

Cats or Kittens entered in **Brace, Team, Club** or **Radius Classes** must be entered in at least one other class.

Exhibitors are responsible for entering their Cats and Kittens in the correct classes.

Neuters can only compete against Neuters; a Brace or Pair **cannot** consist of a Neuter and Breeding stock.

CHAMPIONSHIPS

Two Governing Council Championships will be granted for those breeds where separate Classes are scheduled for each sex, provided the total number of entries in the two Classes is **seven** or more. In cases of amalgamation or where the total entries in the two Classes are less than **seven**, only one Championship will be given.

The following rule was passed at the meeting of the G.C.C.F. held on 10th July, 1935:—

“When the number of exhibits in the two Open Classes is below seven only one certificate should be given. If, however, the winner of the opposite sex be of very high quality, the Judge may be empowered to give the second championship subject to the approval of another recognised Judge of that breed.”

MEMORANDA

Registrations. Exhibitors should register their Cats and Kittens in good time. If left to the last minute and names submitted are not available, registrations may not be received in time to enter. Registration Forms can be obtained from the Registrar, G.C.C.F.

Special Prizes. It will be noticed that all Club Specials are confined to fully paid-up members. Exhibitors should ensure that they have paid their subscriptions for 1960 to avoid disappointment.

To really get the most out of a Show, exhibitors should be members of the Club that is running the Show, in this case, Northern Counties Cat Club. Entry fee 10/-. Subscription 10/-. Join now.

Open Neuter Classes where Premier Certificates are given: 106—110.

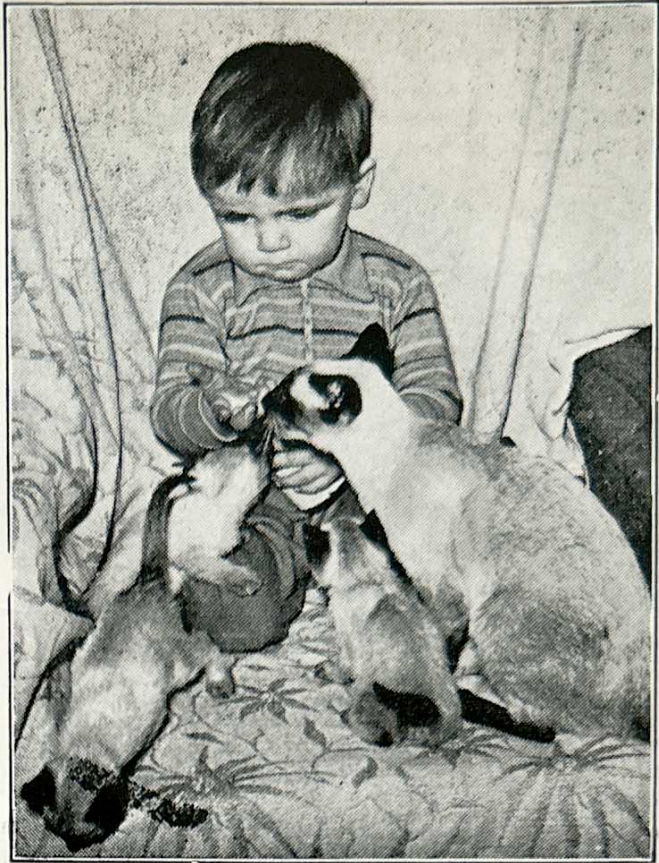
