GENERAL REGULATIONS AND RULES FOR THIS SHOW

The Exhibition is held under the Rules of the Governing Council of the Cat Fancy and is OPEN TO ALL.

Show Committee. The Committee of the Club and any member of the Club nominated by them will form the Show Committee.

Veterinary Surgeon will be in attendance to examine exhibits and to assist the Committee.

Receipt of exhibits will take place at the entrance of the Hall where the Show will be held, from 7 p.m. to 8 p.m. of the evening previous to the opening day, and also 8 a.m. to 10 a.m. on the day of the Show, 28th January, 1961. **NO EXHIBITS WILL BE ADMITTED AFTER 10 a.m.**

The Show will be open to the public at 1 p.m. to 5.30 p.m. Admission 2/-, Children 1/-.

Exhibitors will be allowed to view judging from the Gallery from 10 a.m. to 1 p.m., inclusive charge 2/6d., but it must be distinctly understood that no one will be allowed on the Hall Floor whilst judging is in progress before 1 p.m. **FREE PASS FOR ENTRIES OVER £3.**

Staging and Pens. These will be supplied by Messrs. Benches Ltd. Double pens, 2/6d. extra, will be supplied only at the discretion of the Show Manager, as there is only a limited number available.

Benching Fee 1/6d. for each exhibit except Litters, for which a charge for benching will be 3/6d., including double pen. **NO COMMISSION WILL BE CHARGED ON SALES.**

No exhibit to be penned before being examined by the Club's Veterinary Surgeons. Any Exhibitor so doing will be disqualified from competition and all fees paid forfeited. This Rule will be strictly enforced.

An exhibit may not be removed from its pen except by the Exhibitor, a Judge, or a Steward acting for a Judge. Exhibitors are requested to keep their cats in their pens at all times, except for necessary grooming, etc., as close proximity to other cats may lead to exhibits' distress and discomfort.

The required number of tallies and receipts will be forwarded to each Exhibitor. The tallies must be hung round the neck of each exhibit by means of a white ribbon or tape.

Early Removals. Exhibitors residing over 100 miles from Southport may remove their exhibits at 5 p.m. with the authority of the Show Manager, which must be obtained. There will be no charge for this service, but in the interest of the general public this ruling is subject to alteration.

Judging will commence at 10.15 a.m. prompt on 28th January, 1961.

Minimum entry two classes. A separate fee must be paid for each class.

Catalogues 2/6d. each. Marked Catalogues 4/-.

T.C.P. will be used for disinfecting purposes at this Show.

Exhibitors and visitors are strictly forbidden to interfere with or remove from its pen any exhibit other than their own without the consent of the Show Manager, under penalty of a fine not exceeding £5.

SHOW RULES

1. All Cats and Kittens are eligible for the Show if registered with the Governing Council of the Cat Fancy. Unregistered Cats may enter only in the Unregistered Cat Section.
2. Exhibits at the Club's Shows are received only on the condition that the Club shall not be responsible for any loss or damage to exhibits, boxes or baskets, or in any other way.
3. The Committee reserve the right to cancel or amalgamate any of the classes.
4. Exhibitors must fill in correctly, sign and deliver the Club's authorised entry form before any Show takes place, and they are held solely responsible for the right description of their exhibits.
5. Judges are empowered to withhold any prize or Championship in any class if the exhibits do not in their opinion possess sufficient merit.
6. Prizes will be paid from the Judges' award slips and not from the Catalogue.
7. Exhibitors must provide **SMALL WHITE BLANKETS, SMALL SANITARY TINS and FEEDING UTENSILS** without distinguishing marks. The judges are instructed to pass any pens containing decorations or distinguishing marks.
Peat moss will be provided.
8. Should any of the Judges be prevented from fulfilling their engagements, the Show Committee reserve to themselves the right of appointing other Judges to fulfil their duties.
9. The prescribed declaration on the Club's Show Entry Form that the Exhibitor is the **bona fide owner** of the exhibit, that the exhibit is offered for exhibition subject to the Club's Show Rules and Regulations, must be signed and forwarded to the Show Manager with the entry fees. If a Cat belongs to more than one person, both must be members to compete for the Club's cups, etc., and both must sign the entry form.
10. No Cats or Kittens will be accepted unless accompanied by their owner or representative on both journeys.
11. Exhibits actually received at the Show Hall cannot be withdrawn from competition without the Committee's sanction.
12. The Committee, on behalf of the Club, retain their exclusive right to publish catalogues of their Shows, containing information as to exhibits and names and addresses of Exhibitors.
13. The Club's Committee have the absolute right to fix and limit the number of exhibits at their Shows, and to select, accept or refuse any offers of exhibits and fees from members at their discretion without giving reason for so doing.

14. An announcement in "Fur and Feather" of any alteration or addition made in the Schedule or in these "Regulations," shall be deemed sufficient notice thereof.
15. Should any exhibit be disqualified by the examining Veterinary Surgeon, it must leave the Hall immediately and if, in his opinion, it is desirable, all other exhibits from the same cattery, and the owner thereof, shall be debarred from attending the Show.
16. **Cats and kittens must have clean ears and coats. Strict attention will be paid to this Rule.**
17. If an exhibit is unable to be shown owing to illness, 50% of entry fee will be returned, providing that a veterinary surgeon's certificate is forwarded to Show Manager in **not less than seven days** prior to date of Show.

Correspondence. No reply can be expected to written communications unless accompanied by stamped addressed envelope or postcard.

Registration. Fanciers should register their Cats and Kittens in good time. If they leave it to the last moment and the names they submit are not available, they may not receive their registration in time to enter. Registration Forms can be obtained from the Secretary, G.C.C.F.

Special Prizes. It will be noticed that all Club Specials are confined to fully paid-up members. Fanciers should make sure that they have paid their subscriptions for 1961 to avoid disappointment.

DEFINITIONS OF CLASSES

Litters. For three or more Kittens of same litter over two months and under three months. (See note re penning fees.)

Kittens. For Kittens not exceeding nine months on day of Show. Any exhibit born on 29th April, 1960, is classed as a Kitten up to midnight, 28th January (Show day).

Limit Classes. For Cats and Kittens that have not won more than four first prizes under the Governing Council Rules.

Special Limit for Cats or Kittens that have not won more than two first prizes under G.C.C.F. Rules.

Novice Classes. For Cats and Kittens that have not won a first prize at Shows under the Rules of the Governing Council.

Maiden Class. For Cats and Kittens that have not won first, second or third prizes at Shows under the Rules of the G.C.C.F.

Senior. For Cats over two years on day of Show.

Junior. For Cats under two years on day of Show.

Brace. For two Cats belonging to the same Exhibitor.

Pair. For two Kittens belonging to the same Exhibitor.

Brace Exhibits are judged on individual merit. Pairs on their similarity to each other.

Exhibits entered in Pair, Brace and Team Classes must be entered in at least one Class other than Club Classes.

Team. For three exhibits (not necessarily the same colour) belonging to the same owner, each of which must be entered also in at least one class other than Brace or Club Classes.

N.B.—A team may consist of Cats, Cats and Kitten, Cat and Kittens, or Kittens.

Debutante Kitten Class. For Kittens not previously exhibited under the Rules of the G.C.C.F.

Neuters can compete only in their own Classes, and must be registered with the G.C.C.F. before competing in Premier Classes.

Breeders' Classes. For Cats and Kittens bred by Exhibitor.

In the event of Classes being amalgamated or cancelled, a notice will be posted in a prominent position at the entrance to the Hall.

CHAMPIONSHIP CERTIFICATES

N.B.—The following Rule was passed at the meeting of the G.C.C.F. held on 10th July, 1935:—

“When the number of exhibits in the two Open Classes is below seven, only one certificate should be awarded. If, however, the winner of the opposite sex be of very high quality, the Judge may be empowered to give the second certificate subject to the approval of another recognised Judge of that breed, who must sign the award slip.”
