GENERAL REGULATIONS AND SHOW RULES

The Exhibition is held under the Rules of the Governing Council of the Cat Fancy (which Exhibitors are requested to read) and is open to all.

The Exhibits will be received at the entrance to the Show on the morning of the Show, from 8 a.m. to 9.45 a.m. Judging will commence at 10 a.m.

Each exhibit will be examined on arrival by the Society's Hon. Veterinary Surgeon, and only those considered fit by him may be penned. Unfit exhibits must be removed by their owners and entry fees forfeited. Cats and kittens must have clean ears and coats free from pests.

Exhibits are only received on the condition that the Society shall not be responsible for any loss or damage to Cats, boxes or baskets, or in any other way.

All exhibits must be accompanied by owner or representative. Exhibitors must provide their own food, sanitary pans and drinking bowls. Peat moss will be provided. **Plain white blankets without colour or markings must be provided by exhibitors.**

No decoration or distinguishing objects will be allowed in or on the pens during judging.

Numbered tallies will be forwarded to each exhibitor which must be placed round the neck of the exhibit by means of a **white** tape or ribbon.

Free Passes will be sent to exhibitors making an entry of £4 or over.

All exhibits must be registered with the Governing Council of the Cat Fancy except Litters, Neuters and Household Pets. Forms may be obtained from Mrs. Aitken, Bourneside, Kingsmead Lane, Hindhead, Surrey (all breeds except Siamese), and Miss V. Prentis, 4 Farman Street, Hove, 2 (Siamese only). All registered cats which have changed owners since registration must be transferred at least three weeks before the Show.

The Committee reserve to themselves the right to—

- (a) Appoint other Judges should those advertised be unable to fulfil their engagement.
- (b) Refuse any entry without giving a reason.
- (c) Cancel, amalgamate or divide classes.

Cats and Kittens must be entered in more than one class and a separate fee for each class paid.

While the payment of the usual 10 per cent. commission on sales will not be enforced, it is hoped that if a sale takes place the Exhibitor will give a contribution to the funds. "For Sale" cards will be supplied on application at the Secretary's table.

After judging is over, no exhibit must be removed from its pen other than by its owner. Exhibitors are forbidden to carry their cats round the Show Hall and they must not be held in such a way as to annoy other cats.

Judges are empowered to withhold any prize in any class if the exhibits do not, in their opinion, possess sufficient merit.

An announcement in "Fur and Feather" of any alteration or addition made in the Schedule shall be deemed sufficient notice thereof.

A penning fee of 3s. 0d. per single pen and 2s. 6d. extra per double pen will be charged, to be paid for at the time of entry.

If an exhibit is unable to be shown owing to illness, 50 per cent. of entry fees will be returned on receipt of a Veterinary Surgeon's Certificate not less than seven days prior to date of Show.

All correspondence requiring a reply must be accompanied by a stamped addressed envelope.

Any cat found to be suffering from the effects of drugs on entry or at any time during the Show will be subject to expulsion from the Show on the authority of the Veterinary Surgeon.

Entries should be sent on or before 15th June, 1966, to Mrs. M. A. Wilson "Amberley," Verwood, Dorset. Exhibitors are responsible for entering their cats and kittens in the correct classes.

There will be no early removals. The Show will close at 5.30 p.m.

Any other variety. Cats and kittens registered as breeds No. 13a and No. 26 may be entered only in A.O.V. Open Classes and in such further classes as Clubs may decide to put on for them.

Any exhibitor whose exhibit has been rejected or withdrawn on veterinary grounds from any G.C.C.F. Show, should produce a Veterinary Surgeon's clearance certificate stating that the Cat(s) in question was recovered on a specific date and/or that there were no further outbreaks in the cattery. A veto to be put on the exhibitor until clearance be notified and all Show Managers notified to prevent entries being taken.

The G.C.C.F. recommends that Exhibitors should not show a cat or kitten more than once within 14 days.

WARNING. Breeders and owners are hereby warned by the Governing Council of the Cat Fancy against the danger of selling whole litters to one buyer, as unfortunate consequences may follow.

DEFINITION OF CLASSES

(A month means a calendar month)

Kittens. For kittens under nine months and over 2 months on the day of Show.

Novice. For cats and kittens that have not won a First Prize under G.C.C.F. Rules. Wins as kittens do not qualify in cat classes unless class is for cats or kittens

Breeders. For cats or kittens bred by exhibitor.

Senior. For cats two years old or over on day of Show.

Junior. For cats under two years old on day of Show.

Litter. For three or more kittens of the same litter over 2 months and under three months on day of Show. Kittens entered in litter classes cannot be entered in any other class.

Stud Cat. To be judged by progeny. Both must be present.

Brood Queen. To be judged by progeny. Both must be present.

Limit. For cats that have not won more than four First Prizes.

Team. For three exhibits (not necessarily the same colour) belonging to the same owner, each of which must be entered also in at least one class other than Brace or Club classes.

Novice Exhibitors. For cats or kittens whose owners have never won a money prize at any Show held under G.C.C.F. Rules. The exhibits themselves may be prize-winners.
