SHOW RULES AND REGULATIONS

1. The Exhibition is held under the rules of the Governing Council of the Cat Fancy, and is open to all.
2. The cats will be received at the entrance to the Show on Saturday, 7th October, from 8.45 to 10 a.m., at the Music Hall, George Street.
3. **NO CAT OR KITTEN CAN BE SHOWN MORE THAN ONCE WITHIN 14 DAYS.**
4. **NO CAT OR KITTEN THAT HAS BEEN DECLAWED MAY BE ENTERED IN THE SHOW.** (Rule confirmed by G.C.C.F., 1.6.67.)
5. Your attention is drawn to the amended Rule 32: No exhibitor shall exhibit a cat or kitten which to his or her knowledge has, at the date of the Show, been exposed to any specified infectious or contagious illness within the period of three months prior to the date of the Show, and no cat or kitten may be exhibited if the exhibitor has had any such illness in his or her cattery during that period. In case of a contagious or infectious disease having occurred in a cattery, a Clearance Certificate will be required from a fully qualified veterinary surgeon. Any exhibitor who, in the opinion of the Council, shall have made a false declaration in respect of the above, will be liable to severe penalties under the powers of the Council.

Specified infectious or contagious illnesses are: 1, Feline infectious enteritis; 2, Ulcerative homatitis in kittens; 3, All types of influenza, including nasal catarrh.
6. Each exhibit will be examined on arrival by the Club's Hon. Veterinary Surgeon, who will be in attendance. Cats which in his opinion are unfit for exhibition will be returned to their owners and the entry fees forfeited. No exhibit is to be penned before being examined by the Club's Veterinary Surgeon. Any exhibitor so doing will be disqualified from competition and all fees paid forfeited. This rule must be strictly enforced.

Any exhibitor whose exhibit has been rejected or withdrawn on veterinary grounds from any G.C.C.F. Show must produce a Veterinary Clearance Certificate stating that the Cat(s) and/or Kitten(s) in question was recovered on a specific date and/or there were no further outbreaks in the cattery.
7. Veterinary Surgeons appointed by Clubs to pass cats will be instructed not to admit cats which are obviously in kitten, or male cats which are either monorchid or cryptorchid. No kittens may be shown that are under three calendar months old on the first day of the Show, except in litter classes, unless between May 1st and October 1st. No nursing queen may be entered as an exhibit except as a brood queen, nor must she be separated from her litter.
8. **Cats and Kittens must have clean ears and coats. Strict attention will be paid to this Rule.**
9. Exhibitors may view the judging from 10.15 a.m. to 1 p.m. from the gallery. The Show will be open to the public from 1 p.m. to 5.30 p.m. Entrance Fee: 2/6 adults, 1/- children. Judging will commence at 10.15 a.m. promptly. Free pass to all exhibitors.

A benching fee of 3/- per cat, kitten or litter will be charged, to be paid on the Entry Form.
10. All exhibits must be accompanied throughout their journey by the owner or by the owner's bona fide representative. Exhibitors must provide their own food, sanitary pans and drinking bowls. Peat moss is provided at the Hall.
11. Tallies will be forwarded to each exhibitor which must be hung around the neck of each exhibit by means of a white tape, ribbon or elastic, which **MUST NOT BE REMOVED** until after the Best in Show judging. In case tallies do not reach the exhibitor, application should be made at the Secretary's table.
12. Entries unaccompanied by the proper amount of fees will not be accepted.
13. Exhibitors are responsible for the correct description of their cats, and in the event of any dispute arising after purchase shall (on the proof of false or erroneous entry) receive back the exhibit and refund to the purchaser the full amount paid.

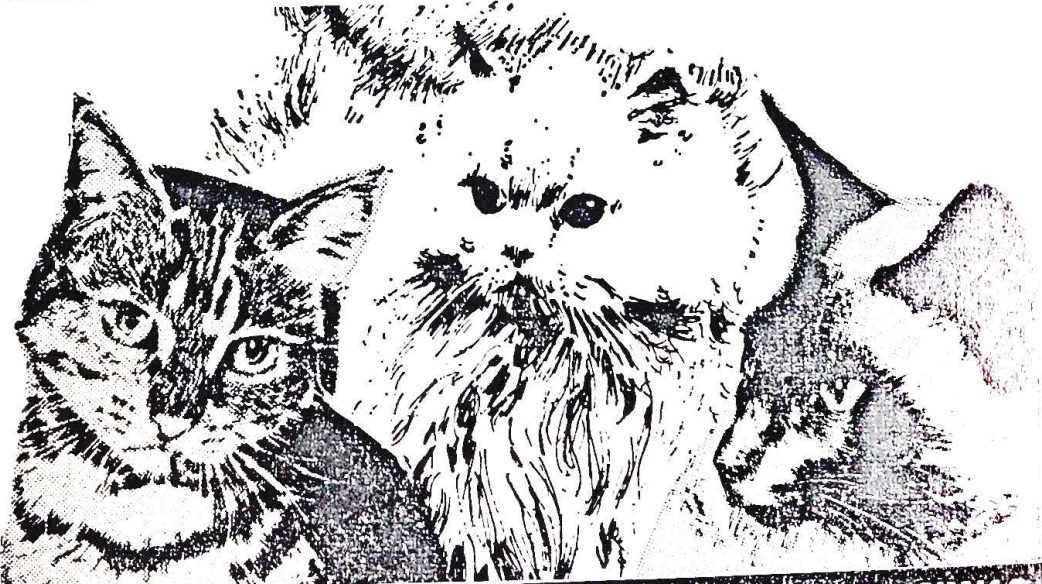

14. All exhibits, except Household Pets, **MUST BE REGISTERED** with the Governing Council of the Cat Fancy. Registration forms can be obtained from Mrs. E. G. Aitken, Bourneside, Kingswood Lane, Hindhead, Surrey, for all Long and Short Hairs, and from Miss V. Prentis, 4 Farman Street, Hove, 2, Sussex, for all Siamese. All registered cats which have changed ownership since registration **MUST BE TRANSFERRED**. Neuters not competing for Premier certificates need not be registered.

15. Cats and Kittens registered as Breeds No. 13a and No. 26 may only be entered in A.O.V. Open Classes and in such other classes as clubs may decide to put on for them.

16. The prescribed declaration on the Club Show Entry Form that the exhibitor is the bona fide owner of the exhibit, and that the exhibit is offered for exhibition subject to the Club's Show Rules and Regulations, must be signed and forwarded to the Show Manager with the Entry Fees. If the cat belongs to more than one person, **BOTH** must be members to compete for cups, etc., offered by clubs, and both must sign the Entry Form as owners and exhibitors.

17. Exhibits actually received into the Show Hall cannot be withdrawn without the Committee's sanction.

18. No interior or exterior decoration, or distinguishing objects, will be allowed in or on the pens during the judging under any circumstances whatsoever and it will be an instruction to the judges to pass any pen so distinguished. **WHITE BLANKETS. WITHOUT MARKINGS, AND SANITARY TINS MUST BE PROVIDED.** Exhibits with coloured or lined blankets will be disqualified.

19. No Stud advertisement or written or printed matter of any kind other than the official award cards may be put on pens.

20. Exhibits are only received on condition that the Club shall not be responsible for any loss or damage to cats, boxes or baskets or in any other way.

21. Entries will not be accepted from judges officiating at this Show, or from any member of a judge's household (see G.C. Rule 9).

22. Exhibitors wishing to advertise for sale a cat or kitten which is not priced in the catalogue must apply at the Secretary's table for an official "FOR SALE" card.

23. The Committee, on behalf of the Club, retain their exclusive right to publish catalogues of their Shows, containing information as to exhibits and names and addresses of exhibitors, and reserve to themselves the right to **REFUSE ANY ENTRY WITHOUT GIVING A REASON.**

24. Prizes will be paid from the judges' award slips, and cats will be sold from entry forms and not from catalogue.

25. Judges are empowered to withhold any prize or championship in any class if the exhibits do not, in their opinion, possess sufficient merit. No judge shall bring out more than one cat for Best in Show, no matter how many different varieties he may be judging.

26. Should any judges be prevented from fulfilling their engagements, the Committee reserve to themselves the right of appointing other judges in their stead.

27. Any exhibitor in any way interfering with or removing any cat from its pen during the Show, except with the consent of the Show Manager, will forfeit any prize that may have been awarded to his or her cat. No-one may remove any exhibit from its pen except the owner or a Club official. Penalty for contravention of this rule is £5.

28. Cats and kittens may be entered in more than one class if eligible, but a separate fee for each class must be paid. No kitten can be entered or shown in adult classes unless stated for cat or kitten.

29. The right to cancel or amalgamate classes is reserved.

30. Cats or kittens entered in Brace, Club or Radius Classes must be entered in at least one other class as well.

31. **EXHIBITORS ARE RESPONSIBLE FOR ENTERING THEIR CATS AND KITTENS IN THE CORRECT CLASSES.**

ENTRIES CLOSE 4th SEPTEMBER, 1967 (Postmark) and should be sent on or before that date to Mrs. S. Bowen, Oak Cottage, 106 St. John's Road, Edinburgh, 12. **NO LATE ENTRIES WILL BE ACCEPTED.**

33. An announcement in "Fur and Feather" of any alterations or additions made in the Schedule shall be deemed sufficient notice thereof.

34. A snack counter in the Show Hall will be open all day from 10 a.m. and lunch will be served from 12 noon. Please state number of lunches required on entry form.

35. **Correspondence.** No reply can be expected to written communications unless accompanied by a stamped addressed envelope or postcard.

THE CLUB DINNER will be held at The Carlton Hotel, North Bridge (Nr. Waverley Station), cost per head 22/6. Please state on Entry Form number of tickets required. (All Exhibitors welcome, but number of tickets limited.)

DEFINITION OF CLASSES

OPEN. Open to all.

BREEDERS. For Cats and Kittens bred by Exhibitor.

NOVICE. For Cats and Kittens that have not won a First Prize under G.C.C.F. Rules. Wins as Kittens do not disqualify in Cat Classes unless Class is for Cats or Kittens.

SENIOR. For Cats two years old or over on day of Show.

JUNIOR. For Cats under two years on day of Show.

LITTER. For three or more Kittens of the same Litter over two and under three calendar months on the day of the Show.

KITTENS. For Kittens three to nine months on the day of the Show.

BRACE. For two Cats (not necessarily the same colour) belonging to the same owner.

HOUSEHOLD PETS. For Non-Pedigree Cats.

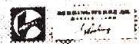

L.H.—Long-Haired; S.H.—Short-Haired; A.V.—Any Variety; A.C.—Any Colour; M.—Male; F.—Female; S.P.—Seal-pointed; B.P.—Blue-pointed; C.P.—Chocolate-pointed; A.O.C.—Any Other Colour; A.O.V.—Any Other Variety.

Breeders and Owners are hereby warned by both the Governing Council of the Cat Fancy and by the Club against the dangers of selling whole litters to one buyer, as unfortunate consequences may follow.

CHAMPIONSHIPS

Two Governing Council Championships will be granted for those breeds where separate Classes are scheduled for each sex, provided the total number of entries in the two Classes is seven or more. In the case of amalgamation or where the total entries in the two classes are less than seven, only one Championship will be given.

The following rule was passed at the meeting of the G.C.C.F. held on 10th July, 1935: "Where the number of exhibits in the two Open Classes is below seven only one Certificate should be given. If, however, the winner of the Opposite Sex be of very high quality, the Judge may be empowered to give the second Championship, subject to the approval of another recognised Judge of the breed."

CATS ON EXHIBITION

CHAMPION COYLUM MARCUS

Marcus is a male White Long-Hair with orange eyes, bred by his owner, Miss Sellar, Surrey. He was born early in 1965, an illustrious son of illustrious forebears, and himself became a Champion in 1966. We are proud that he gained a Challenge Certificate in Edinburgh in that year and was best L.H. Adult in the Show. Amongst his many awards is the International Golden Rosette for Great Britain. He is, currently, British "Ambassador" to the American White Persian Society.

SNOWBALL and DENISLA BLACK IMP

Imp and Snowball are of a strain of Lop-Eared Cats bred by Mr. William Ross, Clackmannan. The strain first made its appearance in 1961. Whilst Lop-Eared Cats are very rare now, it is interesting to note that in Chinese drawings, many hundreds of years old, Lop-Eared Cats occasionally make an appearance. However, though there may be "nothing new under the sun," to Scotland, and indeed, Great Britain, Mr. Ross's cats are an interesting and unusual breed.
