GENERAL REGULATIONS

IMPORTANT—Please read these Rules, they will be strictly adhered to.

Any cat or kitten found to have had its claws removed will, on examination by the Veterinary Surgeon, be debarred from the Show.

The G.C.C.F. rules that Exhibitors will not show a cat or kitten more than once within 14 days.

Each exhibit will be examined on arrival by the Club's Hon. Veterinary Surgeon and **no exhibit is to be penned before being seen by him.**

Cats which are unfit for exhibition will be removed from the hall immediately, and if in the Vet.'s opinion it is desirable, all other exhibits from the same cattery, and the owner thereof, shall be debarred from attending the Show. All entry fees will be forfeited.

A penning fee of 3s. 6d. will be charged for every exhibit, to be paid on the entry form. Double pens 5s. Litter pens 5s. Penning by Messrs. Benches Ltd.

Exhibition pens 7s. 6d. inclusive.

The cats will be received at the entrance to the Show on Saturday, July 1st, from 8.30 a.m. till 9.30 a.m.

The Show will be open to the public at 12 noon, July 1st, admission 3s. (O.A.P. and Children 1s. 6d.). After 5 o'clock, 1s. Tickets from 10 onwards, 3s. on application to the Show Manager with entry fees. Before 12 noon no-one will be allowed in the gangways.

Admission Tickets. All members can render great assistance to the Club by selling tickets in advance. Application should be made to Mrs. Johnson as soon as possible, stating the number required (please enclose cheque with enquiry).

Judging will begin at 10 a.m. promptly.

All exhibits must have clean ears and be free from vermin.

All exhibits must be accompanied by owner or representative. Exhibitors must provide their own food, sanitary pans and drinking bowls. Peat moss is provided at the hall.

Tallies will be forwarded to each exhibitor, and must be hung round the neck of each exhibit by means of a white tape, ribbon or elastic. If these do not arrive before the Show please apply to the Show Manager in the hall.

All exhibits must be in baskets or suitable containers—NO EXHIBIT WILL BE ACCEPTED ON LEAD ONLY.

Cats and Kittens may be entered in more than one Class if eligible, but a separate fee for each Class must be paid.

No Kitten may be entered or shown in any Adult Class not expressly stated to be for Cats or Kittens.

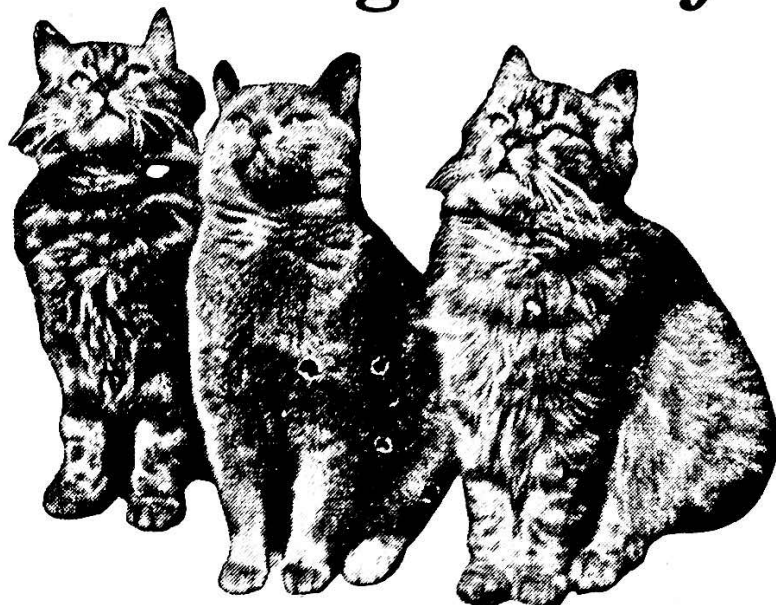
Cats and Kittens entered in Pairs, Brace, or Club Classes must be entered in at least one other Class as well.

Catalogues (price 2s. 6d. each) will be forwarded after the Show by post on receipt of remittance by the Show Manager, price 3s. 6d. post free. Marked catalogue, 4s. 6d. post free.

No interior or exterior decorations or distinguishing objects, such as coloured blankets, will be allowed in or on the pens in any circumstances whatever, and it will be an instruction to the judges to pass any pen so distinguished. **Plain white blankets**, without markings, and **small sanitary tins** **MUST** be provided. Hot water bottles in plain white covers with no distinguishing marks will be allowed in the pens during the Show.

No stud advertisement or written or printed matter of any kind, other than the official award cards, may be put on the pens. Exhibitors wishing to advertise for sale a Cat or Kitten which is not priced in the catalogue must apply at the Secretary's table for an official "For Sale" card.

No queen in kitten nor any nursing queen may be exhibited. A nursing queen may, however, accompany her litter.

A **S.H. Litter** may not be shown or sold under the age of 10 weeks, a **L.H. Litter** under 8 weeks.

Individual S.H. Kittens may not be shown or sold under the age of 12 weeks and individual **L.H. Kittens** under the age of 10 weeks.

Kittens bought from this Show will not be allowed to leave the hall except in a suitable container.

Exemption has been granted by the G.C.C.F. for the exhibition of registered Cats.

THE GOVERNING COUNCIL OF THE CAT FANCY EXEMPTION SHOW RULES

1. All exhibits must be carefully examined by a Veterinary Surgeon before being penned. At least one qualified Veterinary Surgeon must be appointed to attend each Show, and such Veterinary Surgeon shall (a) examine each exhibit at the entrance of the Show (and during the Show if required); and if, in his opinion, an exhibit is not fit to enter or remain in the Show, he shall give his opinion in writing, stating his reasons, and shall lodge the same with the Show Secretary as soon as possible. Any exhibit disqualified from exhibition by the examining Veterinary Surgeon shall leave the hall immediately and if, in his opinion, it is desirable, all other exhibits from the same Cattery and the owner thereof shall be debarred from attending the Show. (b) Examine at the Show any exhibit against which an objection is brought on the grounds of its suffering from any contagious or infectious disease, or its having been prepared for exhibition in contravention of these Rules made by the Council, and give in writing his duly signed opinion to the Show Secretary before the Show closes. The Show Manager, with the approval of a member of the Show Committee, and a member of the Council, is hereby empowered to remove to the Show's isolation hospital without reference to the Vet. Surgeon, if that official should be for any reason not available, any exhibit suspected to be suffering from a contagious or infectious disease; but this notwithstanding, every effort should be made by the Show Management to obtain the attendance of the Show Veterinary Surgeon, or of some other Veterinary Surgeon, at the first opportunity. Any exhibit so objected to must not be removed from the Show premises without the Show Manager's permission. (c) Owners of rejected exhibits shall not themselves attend Shows within the prescribed period of three months, unless a clearance certificate from a Veterinary Surgeon be received 14 days after this Show. Such Certificate to be forwarded to the Secretary.

2. A Show Committee may reserve the right to refuse any entry or entries without giving any reason. A Show Committee shall fix a day for closing its entries, and such date must be published in the official organ of the Council. Shows run under G.C.C.F. Rules must be run by a Show Committee and the names of this Committee (indicating the Chairman) must be printed in the schedules and catalogues of all Shows.

3. Show Managers may exhibit for competition at Exemption Shows only.

4. All exhibits must be accompanied throughout their journeys by the owner or the owner's representative.

5. A litter may not be shown under the age of two calendar months nor any kitten or kittens be sold at any Show under this age.

6. No Queen in kitten nor any nursing Queen may be exhibited. A nursing Queen may, however, accompany her litter.

7. The Show Schedule and Catalogue must both distinctly state on the covers that Exemption has been granted by the Governing Council of the Cat Fancy for the exhibition of registered Cats.

8. Neuters shall count as progeny. Neuters can only compete for Prizes and Specials confined to Neuters.

12. **Early Removals.** Exhibitors living at a distance of 100 miles or more from the Show may remove their exhibits at 5 p.m. at a charge of 2s. per exhibit. No others may leave the Show until 6 o'clock except those that have been sold; these can be removed at 4 p.m. **APPLICATION FOR EARLY REMOVAL MUST BE MADE TO THE SHOW MANAGER WITH ENTRY FORM. THIS RULE WILL BE STRICTLY ADHERED TO.**

13. Any Cat found to be suffering from the effects of drugs on entry or at any time during the Show will be subject to expulsion from the Show on the authority of the Veterinary Surgeon.

14. All exhibitors are forbidden to carry their Cats and Kittens round the Show Hall and they must not be held in such a way as to annoy other Cats and Kittens.

WARNING.—Breeders and Owners are hereby warned by the Governing Council of the Cat Fancy against the danger of selling **WHOLE LITTERS** to **ONE** buyer as unfortunate consequences may follow.

Any cat or kitten found to have had its claws removed will, on examination by the Veterinary Surgeon, be debarred from the Show.

The G.C.C.F. rules that Exhibitors will not show a cat or kitten more than once within 14 days.

No exhibit to be entered in more than 10 classes.

1. **ANY OTHER VARIETY.** Cats and Kittens registered as Breeds No. 13a and No. 26 may only be entered in A.O.V. **Open** Classes and in such further classes as Clubs may decide to put on for them.

2. That any exhibitor whose exhibit had been rejected or withdrawn, on veterinary grounds, from any G.C.C.F. Show, should produce a veterinary surgeon's clearance certificate stating that the cat(s) in question was recovered on a specific date and/or that there were no further outbreaks in the cattery.

A veto to be put on the exhibitor until clearance be notified, **and all Show Managers notified** to prevent entries being taken.

DEFINITION OF CLASSES

Novice. For Cats and Kittens that have not won a First Prize. Wins as Kittens do not qualify in Cat Classes unless Class is for Cat or Kittens.

Kittens. For S.H. Kittens 3-9 calendar months old on the day of the Show. For L.H. Kittens 10 weeks—9 months on day of Show.

Breeders. For Cats or Kittens bred by exhibitor.

10. A full copy of the above Rules must be printed in each Schedule and Catalogue.
11. Subject to the above conditions a Club or Society is free to run a Show under its own Rules.

SHOW RULES

1. Exhibitors are responsible for the correct description of their Cats, and if dispute arises after purchase shall (on proof of false or erroneous entry) receive back the exhibit and refund to the purchaser the full amount paid.

2. The Kentish Cat Society cannot hold themselves responsible for Cats or Kittens bought at the Show.

3. Judges are empowered to withhold any prize in any Class if the exhibits do not in their opinion possess sufficient merit.

4. Prizes will be paid from the Judges' award slips and not from the catalogue, and Cats will be sold from the entry forms and not from the catalogue.

Special Prizes. It will be noticed that all Club Specials are confined to fully paid-up members. Members exhibiting should make sure that they have paid their subscription for 1967 to avoid disappointment.

5. Should any Judges be prevented from fulfilling their engagements, the Committee reserve to themselves the right of appointing other judges in their stead.

6. Entries unaccompanied by the proper amount of fees will not be accepted.

7. Exhibits actually received in the Show Hall cannot be withdrawn from competition.

8. The Committee reserve to themselves the right to refuse any entry without giving a reason.

9. An announcement in "Fur and Feather" of any alteration or addition made in the schedule or in these regulations shall be deemed sufficient notice thereof.

The right to cancel or amalgamate Classes is reserved. Classes of less than five entries will be cancelled or amalgamated unless guaranteed.

10. The Committee will be most anxious for the care and safety of the Cats sent for exhibition, but it must be distinctly understood by exhibitors and all other persons that the Committee will not be responsible for the loss, detention of, or damage to any Cats, baskets, or other property, whether arising from accident or any other causes whatsoever, or from any act or omission of themselves, their officers, agents, servants, or others, and exhibits are only received on this condition.

11. ALL COMPLAINTS must be made in WRITING WITHIN SEVEN DAYS TO THE SHOW MANAGER.

- Neuters.** Can compete in their own Classes only.
- Brace.** Exhibits are judged on individual merits, Pairs on their similarity to each other.
- Litters—Short-Hairs.** Three or more Kittens over ten weeks and under three calendar months on the day of the Show. **Long-Hairs:** Three or more Kittens over eight weeks and under three calendar months on day of Show.
- Novice Exhibitors.** For Cats or Kittens whose owners have never won a money prize at any Show held under G.C.C.F. Rules. The exhibits themselves may be prize winners.
- N.B.—**To qualify for the lower entry fee for **Club Classes** exhibitors must be members of both the Kentish Cat Society and the Club concerned. Should any Novice exhibitor need help with regard to definition of Rules, etc., the Show Manager will be pleased to assist.

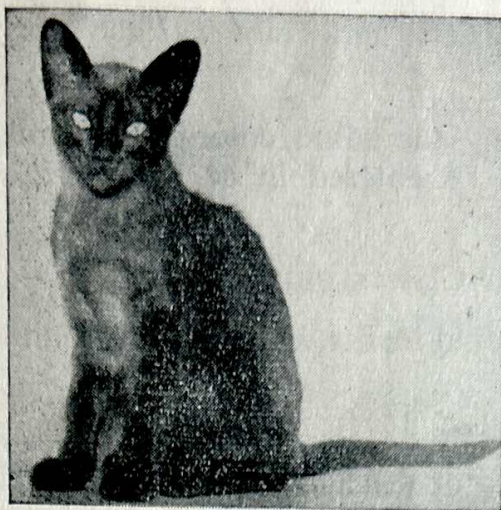
