# THE GOVERNING COUNCIL OF THE CAT FANCY

## EXEMPTION SHOW RULES

1. All exhibits must be carefully examined by a Veterinary Surgeon before being penned. At least one qualified Veterinary Surgeon must be appointed to attend each Show and such Veterinary Surgeon shall (a) examine each exhibit at the entrance of the Show (and during the Show if required); and if, in his opinion, an exhibit is not fit to enter or remain in the Show, he shall give his opinion in writing stating his reasons, and shall lodge the same with the Show Secretary as soon as possible. Any exhibit disqualified from exhibition by the examining Veterinary Surgeon shall leave the hall immediately, and if in his opinion it is desirable, all other exhibits from the same cattery and the owner thereof shall be debarred from attending the Show; (b) examine at the Show any exhibit against which an objection is brought on the grounds of its suffering from any contagious or infectious disease or its having been prepared for exhibition in contravention of these rules made by the Council and give in writing his duly signed opinion to the Show Secretary before the Show closes. The Show Manager, with the approval of a member of the Show Committee and a member of the Council, is hereby empowered to remove to the Show's isolation hospital without reference to the Veterinary Surgeon, if that official should be for any reason not available, any exhibit suspected to be suffering from a contagious or infectious disease; but this notwithstanding, every effort should be made by the Show Management to obtain the attendance of the Show Veterinary Surgeon or of some other Veterinary Surgeon at the first opportunity. Any exhibit so objected to must not be removed from the Show premises without the Show Manager's permission. (c) Owners of rejected exhibits shall not themselves attend Shows within the prescribed period of three months unless a clearance certificate from a Veterinary Surgeon be received 14 days after this Show. Such certificate to be forwarded to the Secretary.

2. A Show Committee may reserve the right to refuse any entry or entries without giving any reason. A Show Committee shall fix a day for closing its entries and such date must be published in the official organ of the Council. Shows run under G.C.C.F. rules must be run by a Show Committee and the names of this Committee (indicating the Chairman) must be printed in the Schedules and Catalogues of all Shows.

3. Show Managers may exhibit for competition at Exemption Shows only.

4. All exhibits must be accompanied throughout their journeys by the owner or owner's representative.

5. A litter may not be shown under the age of two calendar months nor any kitten or kittens sold at any Show under this age.

6. No Queen in kitten nor any nursing Queen may be exhibited. A nursing Queen may, however, accompany her litter.

7. Neuters shall count as progeny. Neuters can only compete for Prizes and Specials confined to Neuters.

G.C.C.F. Rule.—A Cat or Kitten cannot be exhibited twice within a period of 14 days. This rule will be strictly enforced.

No Cat or Kitten that has been de-clawed will be accepted at any Show.

## SHOW RULES

1. Exhibitors are responsible for the correct description of their cats and all handwriting on entry forms should be clear and legible.
2. Judges are empowered to withhold any prize in any class if the exhibits do not in their opinion warrant sufficient merit.
3. Prizes will be paid from the judges' award slips and not from the catalogue.
4. If a cat or kitten belongs to more than one person, both must be members to compete for cups, etc., and must both sign the entry form.
5. Entries unaccompanied by the correct amount of fess will not be accepted.
6. Exhibits actually received at the Show Hall cannot be withdrawn from competition.
7. The Committee reserve the right to refuse any entry without giving a reason.
8. An announcement in "Fur and Feather" of any alteration or addition made in the Schedule or in the "Regulations" shall be deemed sufficient notice thereof.
9. All complaints must be made in writing, within seven days, to the Show Managers.
10. No exhibit shall be removed from the Show Hall before the end of the Show without a pass signed by the Show Manager. This rule will be strictly enforced.
11. Any cat or kitten found to be suffering from the effect of drugs on entry or at any time during the Show, will be subject to expulsion on the authority of the Veterinary Surgeons.
12. Exhibitors are forbidden to carry cats or kittens around the Show Hall or to hold them in such a way as to annoy other cats or kittens. The use of leads is forbidden.

## DEFINITION OF CLASSES

**Open Class.** For Cats and Kittens of the same breed number.

**Novice.** For Cats and Kittens which have not won a 1st Prize at Shows held under the Rules of the Governing Council.

**Kittens.** Long-haired Kittens and Household Pet Kittens over 10 weeks and not exceeding 9 months on the day of the Show.

Short-Haired Kittens (including Siamese) over 3 months and not exceeding 9 months on the day of the Show.

**Breeders.** For Cats and Kittens bred by exhibitor.

**Limit.** For Cats and Kittens which have not won more than four 1st Prizes at Shows under the Rules of the G.C.C.F.

**Neuters.** Can compete in their own classes only.

## GENERAL REGULATIONS AND RULES FOR THIS SHOW

The Exhibition is held under the Rules of the Governing Council of the Cat Fancy.

Exemption has been granted by the Governing Council of the Cat Fancy.

Cats will be received at the entrance to the Show Hall on Saturday, 12th July, 1969, between 8 a.m. and 9.30 a.m. Veterinary Surgeons will be in attendance and **NO EXHIBIT CAN BE PENNED BEFORE SEEING THEM.**

**FAILURE TO OBSERVE THIS RULE WILL RESULT IN DISQUALIFICATION FROM COMPETITION AND ALL FEES PAID WILL BE FORFEITED.** Cats which are unfit for exhibition will be removed from the hall immediately, and if in the Vet.'s opinion it is desirable, all other exhibits from the same cattery, and the owners thereof, shall be debarred from attending the Show. All entry fees will be forfeited.

No exhibits overnight.

A penning fee of 5/- per cat will be payable. Double pens may be supplied (space permitting) for Adult Males, Litters and Neuters only on payment of 2/6d. extra. Exhibition pens (space permitting) at an inclusive fee of 12/6d.

The Show will be open to the public at 12.30 p.m. Admission 3s., Children and O.A.P.s 1/6d. No exhibitors will be allowed in the gangways before 12.30 p.m.

**JUDGING WILL BEGIN AT 10 a.m. PROMPT.**

**ALL EXHIBITS** must have clean ears and be free from vermin.

**ALL EXHIBITS** must be accompanied by owner or owner's representative.

Exhibitors must provide their own food and drinking bowls, also **SANITARY TRAYS. THESE ARE MOST IMPORTANT TO THE COMFORT OF YOUR CAT.**

Tallies will be forwarded to each exhibitor and must be hung round the neck of each exhibit by means of a WHITE tape, ribbon or narrow elastic. If for any reason these are not received, please apply to the Show Manager on the morning of the Show.

Clean white woollen blankets MUST be provided. Hot water bottles in plain white covers will be allowed in the pens, but neither blankets nor bottles must bear any distinguishing marks. No interior or exterior decorations or objects will be allowed in or on the pens under any circumstances. Judges are instructed to pass any pens so distinguished.

ALL EXHIBITS must be in BASKETS or suitable CONTAINERS. NO EXHIBIT will be accepted on lead alone.

Cats and kittens must be entered in more than one class but the separate fee for each class must be paid. (With the exception of Litter Classes.)

No kitten may be entered or shown in any Adult Class not expressly stated to be for cats or kittens and vice-versa.

Any EXHIBITOR or VISITOR in any way interfering with or removing any cat from its pen during the Show, except with the consent of the Show Manager, shall forfeit any prizes awarded. NO-ONE MAY REMOVE ANY EXHIBIT FROM ITS PEN EXCEPT THE OWNER OR A CLUB OFFICIAL. PENALTY FOR CONTRAVENTION OF THIS RULE IS £5.

No Stud advertisements, written or printed matter other than the award cards may be put on the pens.

No Queen in kitten or any nursing queen may be exhibited.

WARNING.—Breeders and Owners are hereby warned by the Governing Council of the Cat Fancy against the dangers of selling WHOLE LITTERS to ONE buyer as unfortunate consequences have been known to follow.

## MEMORANDA

Exhibits are received only on condition that the Club shall not be responsible for any loss or damage to exhibits, boxes, baskets, or in any other way.

Should any judge be prevented from fulfilling their engagements the Committee reserve the right to appoint other judges.
