FELINE ADVISORY BUREAU

A REGISTERED CHARITY

The **Feline Advisory Bureau** is a national organisation which was founded in 1958 with two main objects :

1. Generally to promote humane behaviour towards the cat and to assure its physical well-being by giving advice to owners on its maintenance in health and care in sickness.
2. To establish such special funds as may be thought desirable to promote investigations into feline disorders.

With regard to the first object, advice to cat owners, the **Feline Advisory Bureau** operates an advisory service which is based on the up-to-date surveying of the appropriate scientific literature and which is supplemented by reference to recognised authorities. For these purposes it maintains an extensive reference and lending library and has established an advisory panel of scientific, medical and veterinary experts. It issues a **Quarterly Bulletin**, containing veterinary and lay articles, and has prepared special leaflets covering diet, exhibiting, breeding, cattery planning and construction, and certain feline disorders. In addition, it operates a boarding cattery inspection scheme. Annual open **Conferences** are held.

With regard to its second object, the promotion of investigations into cat disorders, the **Feline Advisory Bureau** has established its **Central Fund for Feline Research**. The accumulation of Funds has enabled the Bureau to sponsor investigation into some of the cat diseases which are not yet fully understood and for which no effective treatment exists. More money is urgently needed to continue this work.

Membership of the **Feline Advisory Bureau** will entitle **YOU** to advice on all cat problems; not only pedigree breeding animals and laboratory animals, but ordinary household pets, farm and office cats.

A contribution to the **Central Fund for Feline Research** will speed investigation into cat diseases and save thousands of cat lives.
