## EXEMPTION SHOW RULES

1. All exhibits must be carefully examined by a Veterinary Surgeon before being penned. At least one qualified Veterinary Surgeon must be appointed to attend each Show, and such Veterinary Surgeon shall (a) examine each exhibit at the entrance of the Show (and during the Show if required): and if, in his opinion, an exhibit is not fit to enter or remain in the Show, he shall give his opinion in writing, stating his reasons, and shall lodge the same with the Show Secretary as soon as possible. Any exhibit disqualified from exhibition by the examining Veterinary Surgeon shall leave the marquee immediately and if, in his opinion, it is desirable, all other exhibits from the same Cattery and the owner thereof shall be debarred from attending the Show. (b) Examine at the Show any exhibit against which an objection is brought on the grounds of its suffering from any contagious or infectious disease, or its having been prepared for exhibition in contravention of these rules made by the Council, and give in writing his duly signed opinion to the Show Secretary before the Show closes. The Show Managers with the approval of a member of the Show Committee, and a member of the Council, is hereby empowered to remove to the Show's isolation hospital without reference to the veterinary surgeon, if that official should be for any reason not available, any exhibit suspected to be suffering from a contagious or infectious disease; but this notwithstanding, every effort should be made by the Show Management to obtain the attendance of the Show Veterinary Surgeon, or of some other Veterinary Surgeon, at the first opportunity. Any exhibit so objected to must not be removed from the Show premises without the Show Manager's permission. (c) Owners of rejected exhibits shall not themselves attend Shows within the prescribed period of three months, unless a clearance certificate from a Veterinary Surgeon be received 14 days after this Show. Such Certificate to be forwarded to the Secretary.
2. A Show Committee may reserve the right to refuse any entry or entries without giving any reason. A Show Committee shall fix a day for closing its entries, and such date must be published in the official organ of the Council. Shows run under G.C.C.F. rules must be run by a Show Committee and the names of this Committee (indicating the Chairman) must be printed in the schedules and catalogues of all Shows.
3. Show Managers may exhibit for competition at Exemption Shows only
4. All exhibits must be accompanied throughout their journeys by the owner or the owner's representative.
5. A litter may not be shown under the age of two calendar months nor any kitten or kittens be sold at any Show under this age.
6. No Queen in kitten nor any nursing Queen may be exhibited. A nursing Queen may, however, accompany her litter.
7. The Show Schedule and Catalogue must both distinctly state on the covers that Exemption has been granted by the Governing Council of the Cat Fancy for the exhibition of registered Cats.
8. Neuters shall count as progeny. Neuters can only compete for Prizes and Specials confined to Neuters.
9. The G.C.C.F. pattern Award Cards must be used.
10. No exhibit may be exhibited twice within 14 days.
11. Veterinary Surgeons will be instructed not to admit to the Show any monorchid or cryptorchid cat.

## GENERAL SHOW RULES AND REGULATIONS

1. The Exhibition is held under the Exemption Show Rules of The Governing Council of the Cat Fancy.
2. The Exhibits will be received at the entrance to the Show Hall on Saturday, June 20th, from 8 a.m. to 9.30 a.m. Judging will commence at 10 a.m. All exhibits must be in suitable containers, baskets or boxes. No exhibit will be accepted on lead only.
3. Each exhibit will be examined by the Society's Hon. Veterinary Surgeons, who will be in attendance. All exhibits must have clean ears and be free from vermin. Cats which in their opinion are unfit for exhibition will be returned to their owners and entry money forfeited. No exhibit may be penned before being examined. Any exhibitor doing so will be disqualified from competition and all fees paid forfeited. This rule will be strictly enforced.
4. All exhibits must be accompanied by owner or representative. Disposable litter trays and litter will be provided free. Exhibitors must provide their own food for cats and feeding dishes must be white.
5. Exhibitors must provide warm white blankets without distinguishing marks.
6. Tallies will be forwarded to each exhibitor, which must be hung round the neck of each exhibit by means of a white tape, ribbon or elastic, which must not be removed until the Best in Show judging. In case tallies do not reach the exhibitor, application should be made at the Show table.
7. Entries unaccompanied by the proper amount of fees will not be accepted.
8. Registration. All exhibits except Neuters and Household Pets must be registered with The Governing Council of the Cat Fancy. Forms may be had from Miss V. Prentis, 4 Farman Street, Hove, Sussex. Registered cats who have changed owners must be transferred.
9. Exhibits are received on the condition that the Society will not be responsible for any loss or damage to cats, baskets or boxes or in any other way.
10. The Show will be open to the public from 12.30 p.m. to 5.30 p.m. Admission 3s., children half-price if accompanied by an adult.
11. Benching fee will be 4s. 6d. for each exhibit. Double pens, for males only, will be 3s. extra. Exhibition pens 15s.
12. Exhibitors are responsible for entering their cats and kittens in the correct classes and for the correct description of their exhibits.
13. The Committee, on behalf of the Society, retain their exclusive right to publish catalogues of their Show containing information as to exhibits and names and addresses of exhibitors.
14. The Committee reserves the right to cancel or amalgamate classes. An announcement in "Fur and Feather" of any alteration or addition made in the Schedule or in these Regulations shall be deemed sufficient notice thereof.

15. Exhibitors and visitors are strictly forbidden to interfere with or remove from its pen any exhibit other than their own, without the permission of the Show Manager.
16. No exhibit may be removed from its pen before 5.30 p.m. except by permission of the Show Manager.
17. If an exhibit is unable to be shown through illness, 50 per cent. of the entry fees will be returned providing a veterinary surgeon's certificate is received seven days prior to the Show.
18. All correspondence must be accompanied by a stamped addressed envelope if reply is expected.
19. Any complaint must be received in writing by the Show Manager within seven days of the Show.
20. **WARNING.** Breeders and owners are hereby warned by The Governing Council of the Cat Fancy against the danger of selling whole litters to one buyer, as unfortunate results may follow.
21. **NOTE.**—No cat or kitten can be exhibited more than once within 14 days. Penalty—Disqualification.
22. Any cat or kitten found to have its claws removed will, on examination by the veterinary surgeons, be debarred from the Show.
23. Should any Judge be prevented from attending the Show, the Committee reserve the right to appoint other Judges to fulfil their duties.

**Rules passed by the G.C.C.F. on the 8th of April 1970 to take effect from the 1st of June 1970.**

24. As from 1st June 1970, all pedigree Cats and Kittens (entire or Neuter), including kittens in Litter classes, exhibited at a show licenced by the G.C.C.F. must be registered.
25. In any Class other than the Open Classes, Judges may be changed during the course of a Show, in an emergency, with the consent of the Show Manager.
26. Where an exhibit has been rejected or disqualified by a Veterinary Surgeon, the Show Manager shall obtain from the Veterinary Surgeon, the reasons therefor and shall send them to the G.C.C.F. Secretary within 48 hours of the Show. A copy is also to be sent to the Exhibitor.
27. All Exhibitors shall certify on his or her Entry Form that every cat or Kitten entered by him or her has been vaccinated against Feline Infectious Enteritis at least 14 days prior to the Show. Failure to produce, within fourteen days from the date of the Show, if called for by a Show Manager, satisfactory evidence of Vaccination shall constitute grounds for disciplinary action by the G.C.C.F.

### **DEFINITION OF CLASSES**

**OPEN CLASSES** 1 to 22.

**KITTENS.** For kittens over three months and under nine months on day of Show.

**LIMIT.** For cats and kittens who have not won more than four first prizes under G.C.C.F. Rules.

**NOVICE.** For cats and kittens who have not won a first prize under G.C.C.F. Rules.

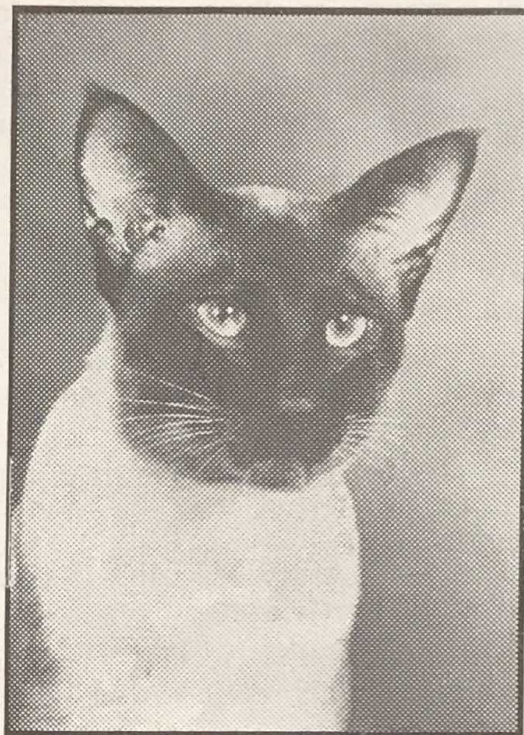

### NOTICE

The breeding of Pedigree Cats is a dedicated hobby for the greater majority of the established breeders in the Cat Fancy, who derive little or no financial gain from their efforts, but do have that more-to-be-prized feeling of achievement when, through their efforts in selective breeding, they can produce a specimen of beauty closely conforming to the standards laid down for the particular breed(s) in which they are interested.

It is regrettable, therefore, that of recent months certain articles which have appeared in the National Press gave the impression that huge profits were to be made from the breeding and sale of Pedigree Kittens, thus inducing various would-be breeders to take up this hobby with the promise of quick and easy profits.

Some of those who have been influenced by these articles are now becoming disillusioned and are disposing of their stock as best they can. The increase in the number of Pedigree Cats now being rescued as strays by Animal Protection Societies indicates that probably some of these "breeders" are even turning their cats loose to fend for themselves. The established members of the Cat Fancy believe this is a phase which will pass in time, but it will have brought untold suffering to numerous cats before breeding is stabilised again.

The Fancy welcomes new members who realise that breeding is a labour of love and that one can expect little, if any, financial gain from one's efforts.
