## EXEMPTION SHOW RULES

1. All exhibits must be carefully examined by a Veterinary Surgeon before being penned. At least one qualified Veterinary Surgeon must be appointed to attend each Show, and such Veterinary Surgeon shall (a) examine each exhibit at the entrance of the Show (and during the Show if required) and if, in his opinion, an exhibit is not fit to enter or remain in the Show, he shall give his opinion in writing, stating his reasons, and shall lodge the same with the Show Secretary as soon as possible. Any exhibit disqualified from exhibition by the examining Veterinary Surgeon shall leave the marquee immediately and if, in his opinion, it is desirable, all other exhibits from the same Cattery and the owner thereof shall be debarred from attending the Show. (b) Examine at the Show any exhibit against which an objection is brought on the grounds of its suffering from any contagious or infectious disease, or its having been prepared for exhibition in contravention of these rules made by the Council, and give in writing his duly signed opinion to the Show Secretary before the Show closes. The Show Managers with the approval of a member of the Show Committee, and a member of the Council is hereby empowered to remove to the Show's isolation hospital without reference to the veterinary surgeon; if that official should be for any reason not available, any exhibit suspected to be suffering from a contagious or infectious disease; but this notwithstanding, every effort should be made by the Show Management to obtain the attendance of the Show Veterinary Surgeon, or of some other Veterinary Surgeon, at the first opportunity. Any exhibit so objected to must not be removed from the Show premises without the Show Manager's permission. (c) Owners of rejected exhibits shall not themselves attend Shows within the prescribed period of three months, unless a clearance certificate from a Veterinary Surgeon be received 14 days after this Show. Such Certificate to be forwarded to the Secretary. (d) Any exhibitor whose exhibit has been rejected or withdrawn, on veterinary grounds, from any G.C.C.F. Show, should produce a veterinary's Surgeon's clearance certificate stating that the cat(s) in question was recovered on a specific date and/or that there were no further outbreaks in the cattery.

WHEN AN EXHIBIT HAS BEEN REJECTED OR DISQUALIFIED BY A VETERINARY SURGEON, THE SHOW MANAGER SHALL OBTAIN FROM THE VETERINARY SURGEON THE REASON THEREFOR AND SHALL SEND THEM TO THE SECRETARY OF THE G.C.C.F. WITHIN 48 HOURS OF THE SHOW. A COPY IS ALSO TO BE SENT TO THE EXHIBITOR.

2. A Show Committee may reserve the right to refuse any entry or entries without giving any reason. A Show Committee shall fix a day for closing its entries, and such date must be published in the official organ of the Council. Shows run under G.C.C.F. rules must be run by a Show Committee and the names of the Committee (indicating the Chairman) must be printed in the schedules and catalogues of all Shows.
3. Show Managers may exhibit for competition at Exemption Shows only.
4. All exhibits must be accompanied throughout their journeys by the owner or the owner's representative.
5. A litter may not be shown under the age of three calendar months nor any kitten or kittens be sold at any show under this age.
6. No Queen in kitten nor any nursing Queen may be exhibited. A nursing Queen may, however, accompany her litter.
7. The Show Schedule and Catalogue must both distinctly state on the covers that the Exemption has been granted by the Governing Council of the Cat Fancy for the exhibition of registered Cats.
8. Neuters shall count as progeny. Neuters can only compete for Prizes and Specials confined to Neuters.
9. The G.C.C.F. Pattern Award Cards must be used.
10. No exhibit may be exhibited twice within 14 days.

21. No commission will be charged on sales.
22. Judging will commence at 10.30 a.m. prompt on Thursday, 24th June, 1971.

### DEFINITION OF CLASSES

**NOVICE.** For Cats and Kittens that have not won a First Prize under G.C.C.F. Rules. Wins as Kittens do not qualify in Cat Classes unless class is for Cats or Kittens.

**KITTENS.** For Kittens over three calendar months and under nine months old on the day of Show.

**BREEDERS.** For Cats or Kittens bred by Exhibitor.

**SENIOR.** For Cats two years old or over on day of Show.

**JUNIOR.** For Cats under two years old on day of Show.

**RADIUS.** For Exhibitors residing within 25 miles of Show.

**VISITORS.** For Exhibitors residing more than 25 miles from Show.

**BRACE.** For two exhibits (not necessarily the same colour) belonging to the same Exhibitor each of which must be entered in at least one class other than Club Classes.

**NEUTERS** can only compete in their own classes.

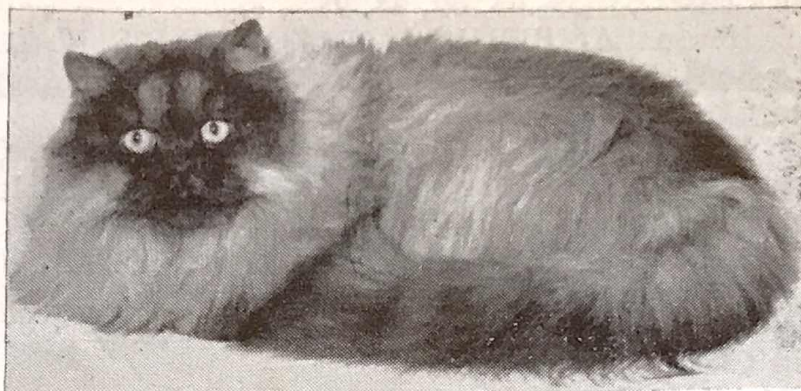

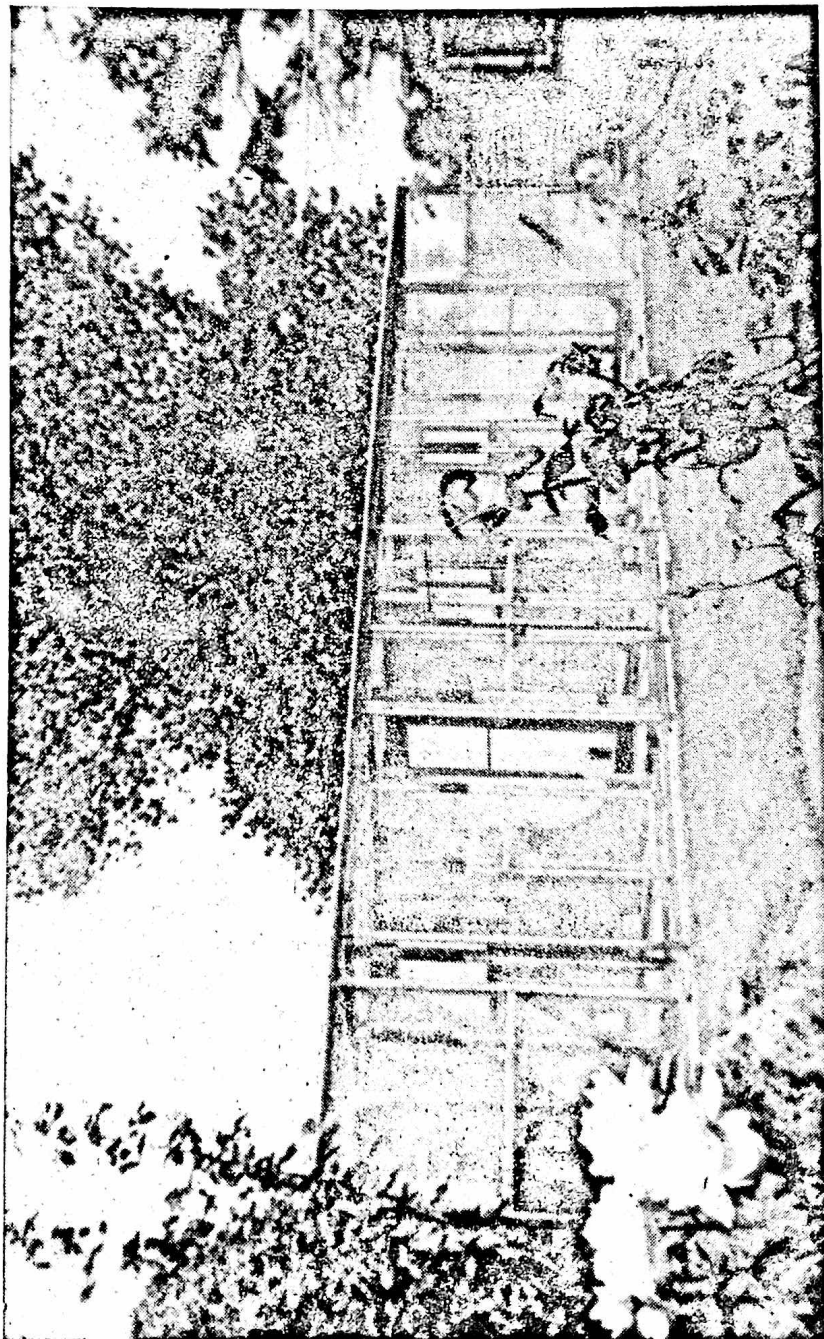

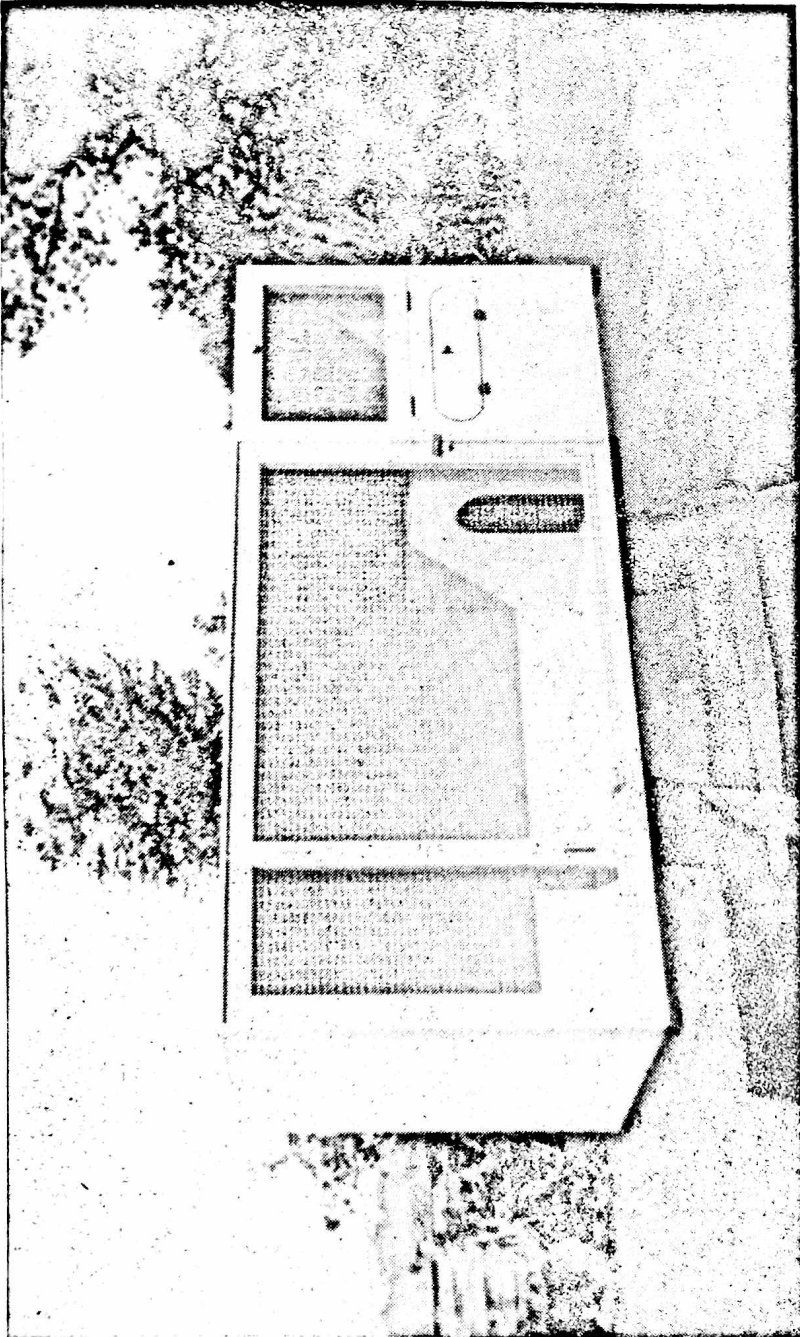
