MARQUEE No. 7

All exhibits must be benched by 10-15 a.m. on the day of the Show. Judging to commence at 10-30 a.m. sharp.

Each exhibit will be examined on arrival by the Society's Veterinary Surgeon, who will be in attendance. Cats which in his opinion are unfit for exhibition will be returned to their owners and the entry fees forfeited. No exhibit is to be penned before being examined. Any exhibitor so doing will be disqualified from competing and all fees paid forfeited. Should any exhibit be disqualified by the examining Veterinary Surgeon, it must leave the Marquee immediately and if, in his opinion, it is desirable, all other exhibits from the same cattery, and the owner thereof, shall be debarred from attending the Show. This rule will be strictly enforced.

All exhibits must be accompanied by owner or representative. Exhibitors must provide their own food, sanitary pans and drinking bowls. Peat moss is provided in the Marquee.

All exhibits must be registered with the Governing Council of the Cat Fancy, except exhibits in Pet Classes.

Exhibits actually received into the Marquee cannot be withdrawn without the Section Manager's sanction. Exhibits are received only on the condition that the Show Committee shall not be responsible for any loss or damage to exhibits, boxes or baskets, or in any other way.

Should any of the Judges be prevented from fulfilling their engagements, the Committee reserve the right of appointing other Judges to fulfil their duties, and also reserve the right to cancel or amalgamate any other classes.

Prize money will be paid by cheque by the City Treasurer within 28 days.

No exhibit shall be removed from the Marquee before 6 p.m. unless permission for removal has been given by the Section Manager.

No unauthorised person will be allowed in the Marquee during judging.

Any objection must be made under Rule 24 of the Governing Council of the Cat Fancy.

The Judge's decision will be final.

The Marquee will be open to the public, when judging is finished.

The Committee reserve the right to amalgamate any classes if less than five entries per class.

Any Other Variety—Cats and kittens registered as breeds No. 13 and No. 26 may only be entered in A.O.V. OPEN classes and in such further classes as clubs may decide to put on for them.

That any exhibitor whose exhibit has been rejected or withdrawn, on veterinary grounds, from any G.C.C.F. Show should produce a Veterinary Surgeon's clearance certificate stating that the cat(s) in question was recovered on a specific date and/or that there were no further outbreaks in the cattery.

No cat, kitten or neuter may be exhibited twice within 14 days.

No cat or kitten that has been declawed may be accepted at any Cat Show or Exhibition of Cats.

The Exhibitor must provide all Cats and Kittens with clean white blankets and suitable sanitary trays, i.e. NOT toffee tin lids, etc.

Definition of Classes

Breeders—For Cat or Kitten bred by exhibitor.

Brace—2 Adults or 2 Kittens.

Novice—For Cat or Kittens who have never won a money prize at any Show.

Novice Exhibitor—Exhibitor who has never shown at any Show.

Litter—Over 2 and under 3 Calendar months. Three or more Kittens.

Radius Classes—For Exhibitors living within a 25 mile radius of Manchester Town Hall.

Visitors' Classes—For Exhibitors living over 25 miles from Manchester Town Hall.

Junior Cat—For Cats over nine months and under two years on day of Show.

Senior Cat—For Cats over two years on day of Show.

Kittens—For Kittens under 9 Calendar months on the day of Show. Kittens under three Calendar months may not be shown except in litter Classes. Kittens in individual classes must be penned separately and must not be entered in litter classes.

The Governing Council of the Cat Fancy Exemption Show Rules

1.—All exhibits must be carefully examined by a Veterinary Surgeon before being penned. At least one qualified Veterinary Surgeon must be appointed to attend each Show, and such Veterinary Surgeon shall (a) examine each exhibit at the entrance of the Show (and during the Show if required); and if, in his opinion, an exhibit is not fit to enter or remain in the Show, he shall give his opinion in writing, stating his reasons, and shall lodge the same with the Show Secretary as soon as possible. Any exhibit disqualified from exhibition by the examining Veterinary Surgeon shall leave the hall immediately and if, in his opinion, it is desirable, all other exhibits from the same Cattery and the owner thereof shall be debarred from attending the Show. (b) Examine at the Show any exhibit against which an objection is brought on the grounds of its suffering from any contagious or infectious disease, or its having been prepared for exhibition in contravention of these rules made by the Council, and give in writing his duly signed opinion to the Show Secretary before the Show closes. The Show Manager, with the approval of a member of the Show Committee, and a member of the Council, is hereby empowered to remove to the Show's isolation hospital without reference to the Veterinary Surgeon, if that official should be for any reason not available, any exhibit suspected to be suffering from a contagious or infectious disease; but this notwithstanding, every effort should be made by the Show Management to obtain the attendance of the Show Veterinary Surgeon, or of some other Veterinary Surgeon, at the first opportunity. Any exhibit so objected to must not be removed from the Show premises without the Show Manager's permission. (c) Owners of rejected exhibits shall not themselves attend Shows within the prescribed period of three months, unless a clearance certificate from a Veterinary Surgeon be received 14 days after this Show. Such Certificate to be forwarded to the Secretary.

2.—A Show Committee may reserve the right to refuse any entry or entries without giving any reason. A Show Committee shall fix a day for closing its entries, and such date must be published in the official organ of the Council. Shows run under G.C.C.F. rules must be run by a Show Committee and the names of this Committee (indicating the Chairman) must be printed in the schedules and catalogues of all Shows.

- 3.—Show Managers may exhibit for competitors at Exemption Shows only.
- 4.—All exhibits must be accompanied throughout their journey by the owner or owner's representative.
- 5.—A litter may not be shown under the age of two calendar months nor any kitten or kittens be sold at any Show under this age.
- 6.—No Queen in kitten nor any nursing Queen may be exhibited. A nursing Queen may, however, accompany her litter.
- 7.—Neuters shall count as progeny. Neuters can only compete for Prizes and specials confined to Neuters.
- 8.—A Cat or Kitten cannot be exhibited twice within a period of 14 days.
- 9.—No Cat or Kitten that has been de-clawed will be accepted at any Show.
