MARQUEE No. 7

All exhibits must be benched by 10-15 a.m. on the day of the Show. Judging to commence at 10-30 a.m. sharp.

Each exhibit will be examined on arrival by the Society's Veterinary Surgeon, who will be in attendance. Cats which in his opinion are unfit for exhibition will be returned to their owners and the entry fees forfeited. No exhibit is to be penned before being examined. Any exhibitor so doing will be disqualified from competing and all fees paid forfeited. Should any exhibit be disqualified by the examining Veterinary Surgeon, it must leave the Marquee immediately and if, in his opinion, it is desirable, all other exhibits from the same cattery, and the owner thereof, shall be debarred from attending the Show. This rule will be strictly enforced.

All exhibits must be accompanied by owner or representative. Exhibitors must provide their own food, sanitary pans and drinking bowls. Peat moss is provided in the Marquee.

All exhibits must be registered with the Governing Council of the Cat Fancy, except exhibits in Pet Classes.

Exhibits actually received into the Marquee cannot be withdrawn without the Section Manager's sanction. Exhibits are received only on the condition that the Show Committee shall not be responsible for any loss or damage to exhibits, boxes or baskets, or in any other way.

Should any of the Judges be prevented from fulfilling their engagements, the Committee reserve the right of appointing other Judges to fulfil their duties, and also reserve the right to cancel or amalgamate any other classes.

Prize money will be paid by cheque by the City Treasurer within 2 months.

No exhibit shall be removed from the Marquee before 6 p.m. unless permission for removal has been given by the Section Manager.

No unauthorised person will be allowed in the Marquee during judging.

Any objection must be made under Rule 24 of the Governing Council of the Cat Fancy.

The Judge's decision will be final.

The Marquee will be open to the public, when judging is finished.

The Committee reserve the right to amalgamate any classes if less than five entries per class.

Any Other Variety—Cats and kittens registered as breeds No. 13 and No. 26 may only be entered in A.O.V. OPEN classes and in such further classes as clubs may decide to put on for them.

That any exhibitor whose exhibit has been rejected or withdrawn, on veterinary grounds, from any G.C.C.F. Show should produce a Veterinary Surgeon's clearance certificate stating that the cat(s) in question was recovered on a specific date and/or that there were no further outbreaks in the cattery.

No cat, kitten or neuter may be exhibited twice within 14 days.

No cat or kitten that has been declawed may be accepted at any Cat Show or Exhibition of Cats.

The Exhibitor must provide all Cats and Kittens with clean white blankets and suitable sanitary trays, i.e., NOT toffee tin lids, etc.

Definition of Classes

Breeders—For Cat or Kitten bred by exhibitor.
Brace—2 Adults or 2 Kittens.
Novice—For Cat or Kittens who have never won a money prize at any Show.
Novice Exhibitor—Exhibitor who has never shown at any Show.
Litter—Over 2 and under 3 Calendar Months. Three or more Kittens.
Radius Classes—For Exhibitors living within a 25 mile radius of Manchester Town Hall.
Visitors' Classes—For Exhibitors living over 25 miles from Manchester Town Hall.
Junior Cat—For Cats over nine months and under two years on day of Show.
Senior Cat—For Cats over two years on day of Show.
Kittens—For Kittens under 9 Calendar months on the day of Show. Kittens under three Calendar months may not be shown except in litter Classes. Kittens in individual classes must be penned separately and must not be entered in litter classes.

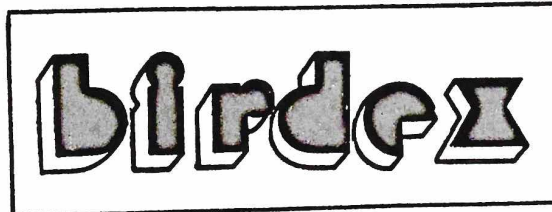
