

### **NEW RULE ON BITING AT SHOWS (Effective 1.6.88)**

Any cat biting or inflicting injury by deliberately scratching a Judge, Veterinary Surgeon, Steward or other Show Official must be reported to the Show Manager. The Show Manager must withdraw the cat from the show and shall inform the owner of the cat in writing, sending a copy to the Secretary of the GCCF. If the cat was defending itself in exceptional and frightening circumstances, that information should be given to the Secretary of the GCCF for consideration by the Executive Committee. If the cat is reported at any subsequent show, it shall be disqualified from all future shows unless the Executive Committee rule otherwise.

### **VETERINARY CLEARANCE CERTIFICATES**

Exhibitors whose cats have been rejected at Shows please note the following points:

1. When sending your clearance certificate to the Veterinary Officer, please include your copy of the rejection slip.
2. Please DO NOT send these certificates by recorded delivery as this can cause considerable delays in the receipt of your certificates. If you wish to satisfy yourself that your letter has reached the Veterinary Officer please enclose a stamped, addressed postcard for acknowledgement of receipt, and this will be signed and returned to you.
3. Exhibitors should not attend Shows until they have received a letter from the Secretary confirming clearance. It is recommended that this letter be taken to Shows within a month of the issue of the clearance letter.
