EXHIBITORS – If your cat has won a Champion, Premier, Grand Champion/Premier, Imperial Grand Champion/Premier or UK Grand Champion/Premier title at a GCCF Show please make your claim to the Office (address above). Please include the cat's name, breed number, sex, breeder's name, owners names and address, together with the names and dates of the qualifying shows and awarding judges' names. All claims are acknowledged and periodically the Title lists are published on the web site shortly after which medals are sent to the owners from the GCCF Office, if they have been ordered when claiming at a cost of £15 per medal (payment with order).

Owners of cats achieving the same title under GCCF and GCCF of Ireland Rules may claim "International " status for that title, by writing to the GCCF Office enclosing written confirmation of having gained the title under GCCF of Ireland Rules. This written confirmation must be signed by the Secretary and stamped with the GCCF of Ireland's Seal

APPLYING FOR A PREFIX - Breeding prefixes cost £75, prefixes for overseas residents/s cost £100 and applicant/s must be a member of a GCCF affiliated cat club at the time of application. Forms are available from the office or online.

REGISTRATIONS AND TRANSFERS - Forms for both are available from the office and online.

CERTIFICATE OF ENTIRETY - All male cats used at stud must have a Certificate of Entirety deposited with the GCCF, prior to registration of kittens. To obtain a Certificate of Entirety, send a stamped addressed envelope to the office or alternatively it is available online. **No fee is charged by the GCCF**. We recommend you keep a photocopy for your own records and to show to **owners of visiting queens**.

MATING CERTIFICATES – Section 1 Rule 3d (effective 1 June 2002) When a litter is registered, the application to register must be accompanied by a copy of the certificate of mating unless the person registering the kitten(s) is also the registered owner of the sire. (Rule added 24.10.2001) The owner of the stud cat must provide a Certificate of Mating to the owner of the queen upon collection of the queen. (amended/effective 29.10.03)

SHOW RULES AND REGULATIONS

The show is held under the Rules of the Governing Council of the Cat Fancy and is open to all. As a copy of the Rules is NOT included with the schedule, all exhibitors are reminded that they should read Section 4 of the Show Rules, as they will be strictly applied. Ignorance will not be accepted as an excuse for a breach of the Rules. Copies of the Rules, price £2, may be obtained from the GCCF Offices, 5 King's Castle Business Park, The Drove, Bridgwater, Somerset. TA6 4AG.

VETERINARY

Any exhibit rejected by the Vet.Surgeon must be removed by its owner and the Entry Fees are forfeit. If in the Vet. Surgeon's opinion, it is desirable, all other exhibits from the same household and owner shall be debarred from attending the show. The Veterinary Surgeon's decision is final.

VETERINARY CLEARANCE CERTIFICATES

Where an exhibit has been rejected or disqualified by a Vet.Surgeon, the Show Managers shall obtain from the Vet the reasons and accordingly notify the GCCF within 48 hours of the Show, ensuring that a copy of the rejection form is forwarded to the exhibitor concerned.

Exhibitors whose cats have been rejected at Shows please not the following points:

- a. When sending your Clearance Certificate to the GCCF Vet.Officer, please include your copy of the rejection slip.
- b. Please DO NOT send certificates by Recorded Delivery as this can cause considerable delays in the receipt of certificates. If you wish an acknowledgement or receipt, please enclose a S.A.Postcard for signature of receipt.
- c. Exhibitors should not attend Shows until they have received a letter from the GCCF office confirming clearance. It is recommended that this letter be taken to shows within one month of issue.

JUDGING AND JUDGES

Judges are empowered to withhold any prize, award or certificate in any class if the exhibits do not, in their opinion, possess sufficient merit. Prizes will be awarded from the Judge's award slip and not from any catalogue or prize card. A Judge's decision is final. An exhibitor may not approach a Judge, or enter into conversation with a Judge until that Judge's engagement is complete.

COUNTERSIGNATURES

In the event of a change of Judge of an Open Class occurring after the closing date of the show, providing the exhibitor informs the Show Managers prior to Judging, that a certificate has previously been awarded by the replacement Judge, the Show Managers shall appoint one other Judge who shall Judge the cat, and if the cat is considered worthy, countersign the certificate which shall then count towards Champion/Premier status.

If the replacement Judge at the first show has also previously been booked for a subsequent show, the closing date of which is before the date of the first show and where the actual entry has been made and received before the date of the first show, then at the subsequent show this Judge can be regarded as a replacement Judge for the purpose of requesting a counter-signature.

Breeders and owners are hereby warned by the GCCF of the unfortunate consequences, which may follow the sale of the whole litter to one buyer. The Black & White Cat Club cannot be responsible for cats and kittens bought at the show neither will they be held responsible for details of such which may appear in the catalogue.



PLEASE SUPPORT OUR RESEARCH PROJECTS

The Cat Welfare Trust is the Fancy's own charity, set up by the GCCF in 1988. The Trust Deed was written to enable funds to be used for the widest possible range of activities to benefit cats. Currently the work of cat rescue is undertaken by GCCF Affiliated Cat Clubs and so the Trust has turned to other ways of improving cat welfare.

Three projects have been undertaken so far, all of which have been funded because the subjects were of particular interest to pedigree cat owners and were not likely to attract commercial funding in their initial stages.

The first of these was a Ph.D. research project to study the preparation of a vaccine for ringworm and was undertaken by Ann Robinson at Bristol University Veterinary School. The second - the Genome Project was undertaken by Dr Matthew Binns of the Animal Health Trust and resulted in the identification and analysis of 211 markers on the feline genome map. The most recent - a study into feline chronic gingivostomatitis - was carried out by Kitty Healey at the University of Liverpool. Chronic gingivostomatitis is a condition familiar to many cat owners, this is a very painful disease affecting the gums and mouths of pet cats causing inflammation and ulceration and there is currently no cure for this condition. Kitty's research has established a link between this condition and FCV reinforcing the need for regular vaccination.

These studies have provided the bases for more specific work within their fields. We have sufficient money to offer £50,000 to fund a fourth project and the Trustees are currently looking for a suitable subject to research. However, the money the Trust can offer for this project is barely sufficient to fund a two year Masters degree study and we will be seeking additional funding from other sources to enable the chosen project to be a PhD study.

The Trust is dependent on donations from the Clubs and members of the Fancy and so it is easy to see that in order to be able to make grants large enough to make a difference to cats' lives we rely on you for all the financial support possible.
