....THE BIRMAN LEGEND

The majestic Birman is known as the Sacred Cat of Burma and it has one of the most colourful histories of any variety of cat. Legend says that centuries ago in the temple of Lao-Tsun lived the high Kittah priest, Mun-Ha, with his faithful white cat, Sinh. One night raiders attacked the temple striking Mun-Ha down leaving him dying.

Sinh turned to face the statue of the golden goddess, Tsu-Kayn-Kse, as he lay with his dying master. As he looked at the goddess with the sapphire blue eyes – his white body turned golden and his yellow eyes turned blue. His legs turned the colour of soil, but his paws which rested on his master's body remained sparkling white.

All the other one hundred temple cats had undergone the same transformation as Sinh. Sinh would not leave his master's side and refusing all nourishment, he died seven days later taking Mun-Ha's soul to paradise. Birmans are still revered in Burma, where many people believe them to be reincarnations of dead priests.

There is some mystery surrounding the actual origins of the Birman, which the Legend fails to explain, perhaps only the Birman knows the truth – should you question them, the only reply you will receive will be a discerning look from their soulful sapphire blue eyes, and the secret will remain eternally theirs. However, legends usually carry certain elements of truth

GENERAL GUIDELINES FOR ENTERING SHOWS

Full Details of exhibiting at GCCF Shows are given in the GCCF Rules Section 4, available on the GCCF website under "About GCCF" and "Forms and Downloads" at www.gccfcats.org or can be purchased for a small charge post free by telephoning the GCCF Office. The Following provides some additional explanation.

Where possible, always complete your show entry form using details from your GCCF Registration Certificate for the cat that is to be exhibited. Please **print** the details carefully to avoid any misinterpretation of your handwriting. If the Registration Certificate you have does not show your name and address this means that the cat is not registered in your name and you must transfer the cat into your name no later than ****10 days** before the show. Transfer can be done instantly using GCCF "**Online Services**" at www.gccfcats.org.

If you have not received your Registration Certificate at the time of entry, complete the show entry form with the details from the pedigree, giving the first choice of name if it is a non-prefix registration, and put RAF (Registration Applied For) or TAF (Transfer Applied For), or both, in the Regd. No. box. It is wise to enclose a stamped self-addressed acknowledgement postcard with all registration and transfer applications, particularly for cats entered for shows, so that you know that the application has been received by the GCCF.

It is recommended that you keep a copy of your entry form – then, when you receive registration details and number, check these against the entry form and notify the Show Manager in writing of any differences in the details as well as giving the registration number, if applicable. This may not be in time for the printing of the show catalogue, but the Show Manager should attach your letter to your entry form which will save unnecessary notification of discrepancies when that show is checked. All catalogue errors are checked against the original entry form and any exhibitors' letters are used for reference. Show managements are permitted to accept corrections, at their own discretion, up to the close of the show (on show day). Any such correction must not be an addition or substitution of any exhibit for which proof of entry cannot be validated, or a change of exhibitor/owner.

If you are entering several cats from your household and the registered owners (exhibitors) differ within that household/family, check with the Show Manager whether using one entry form is acceptable or not and, if it is, indicate **very clearly** which exhibitor owns which cat, ensuring all owners sign the entry form. It may be less confusing and more acceptable to the Show Manager for each owner to use separate entry form, but joint owners of an exhibit should always use the same form and ****at least one of the owners has signed the declaration.**

Exhibitors are reminded that the decisions of the judges are final. Any attempt to influence such decisions, or to identify a cat or ownership of a cat to a judge at a show before that judge's engagement has been completed, may render the offender liable to disciplinary action.

IF THERE IS A MISTAKE ON YOUR ENTRY– WHAT TO EXPECT

Minor Errors

Should a small error be made these will be resolved between Exhibitor, Show manager and/or GCCF. Persistent repetition may result in further action being taken.

Incorrect Date of Birth

This is usually classed as a minor error unless it affects an entry into classes based on age groups, when it could warrant disqualification of the exhibit from such classes; but if the incorrect date of birth affects the age suitability as a whole, then the exhibit will be disqualified from the show.

N.B. AGE LIMITS: Kittens – not less than 14 weeks and under 9 calendar months on date of show
 Adults – not less than 9 calendar months on date of show

IF THERE IS A MISTAKE ON YOUR ENTRY– WHAT TO EXPECT continued

Incorrect Name of Exhibit/Owner

If registration/transfer details were obviously available at the time of entry or before the date of the show, disqualification is inevitable. The following discrepancies are those which usually arise:

EXHIBIT	Totally incorrect name
OWNER/EXHIBITOR }	Declaration not signed by at least one of the registered owner(s)

N.B. The exhibitor(s) must be the registered owner(s) of the cat and **not** necessarily the person who actually takes the cat to the show.

Registration/Transfer Not Received by the GCCF ****10 Days** before the Date of the Show

These entries will be disqualified. Remember, the effective date of all registrations and transfers is the **first date of valid receipt by the GCCF.**

Transfer of Exhibit from Exhibitor to a New Owner Received by the GCCF More Than ****10 Days** before the Date of the Show

Entries such as these will also be disqualified as the exhibitor's entry form becomes invalid.

Incorrect or Ineligibility of Class Entry

These will be disqualified from the class concerned – so always check with the Show Manager if in doubt about which class to enter.

If a breed number is changed officially, it is important that you notify the Show Manager immediately.

Exhibits entered in the Grand, Imperial Grand or Olympian class must have qualified on or before the published closing date of the show **which will include any extension published on the GCCF Website** (amended 21.10.2015) and the title must have been claimed in writing by that date. Exhibitors who enter Grand, Imperial Grand or Olympian classes without claiming the title will be reminded once, but if the title remains unclaimed the cat will be disqualified from this class at subsequent shows.

Cats Registered on the Reference Register

Most cats registered on this Reference Register (CSREF) are not eligible to be shown and, therefore, these entries could be disqualified. One exception to this is when a new breed becomes recognised, and then cats of the breed may be shown, even if they were originally registered on the Reference Register as long as this was the only reason for the Reference registration.

Exhibitors may appeal against any disqualification resulting from show checking, giving their reasons. The appeal will be referred to the GCCF Board if considered valid and, if not, a letter of explanation will be sent to the exhibitor(s). The above advice, however, is aimed at keeping your show entries trouble-free.

TITLES AND/OR MEDALS can be ordered by email or post to the address above. Title & Medal claim forms are available to download from the GCCF website. If applying by email please include the Title claimed, cat's name, breed number, sex, breeder's name, owners name and address, together with the names and dates of the qualifying shows and awarding judges' names. Title lists are published on the web site.

MEDALS COST £16.50 per medal including 1 free bar (excluding Olympian bars), £8 per subsequent bar. Olympian bars (Bronze, Silver or Gold) are £10, if a medal is required with the Olympian bar then the fee is £26.50. UK Medals are £20. Payment with orders please.

Owners of cats achieving the Champion/Premier, Grand Champion/Grand Premier title under GCCF and GCCF of Ireland Rules may claim "International" status for that title, by writing to the GCCF Office enclosing written confirmation of having gained the title under GCCF of Ireland Rules. This written confirmation must be signed by the Secretary and stamped with the GCCF of Ireland's Seal.

APPLYING FOR A PREFIX - Breeding prefixes cost £75, for overseas residents the cost is £100 and applicants must be a member of a GCCF affiliated cat club at the time of application. Forms available from the office or online.

CERTIFICATE OF ENTIRETY - All male cats used at stud must have a Certificate of Entirety supplied to the GCCF signed by a Vet, prior to registration of kittens. This must contain the microchip number of the cat, verified at the time of examination and the Vet's practice stamp.

A Certificate of Entirety form can be downloaded from the GCCF website or by sending an s.a.e to the GCCF Office. **No fee is charged by the GCCF.** We recommend you keep a photocopy for your own records and to show to owners of visiting queens.

MATING CERTIFICATES – Section 1 Rule 3d (effective 1 June 2002) When a litter is registered, the application to register must be accompanied by a copy of the certificate of mating unless the person registering the kitten(s) is also the registered owner of the sire. (Rule added 24.10.2001) The owner of the stud cat must provide a Certificate of Mating to the owner of the queen upon collection of the queen (amended/effective 29.10.03).

MASTER TITLE

The title Master (M) shall be attained by the awarding of three Master certificates by three different judges at participating GCCF Championship shows.

GRAND MASTER TITLE

The title Grand Master (GM) shall be attained by the awarding of three Grand Master certificates by three different judges at participating GCCF Championship Shows.

IMPERIAL GRAND MASTER TITLE

The title Imperial Grand Master (IGM) shall be attained by the awarding of five Imperial Grand Master certificates by five different judges at participating GCCF Championship Shows.

OLYMPIAN MASTER TITLE

The Olympian title shall be attained by the awarding of five Olympian certificates by 5 different judges at participating Championship or Sanction GCCF shows. Only one certificate is allowed at one breed show at each level. The first five awards will be noted with the title Olympian Bronze, the 2nd five will be noted with the title of Olympian Silver and the 3rd five will be noted with the title of Olympian Gold (total fifteen certificates to reach Olympian Gold).

MEDALS COST £16.50 per medal including 1 free bar (excluding Olympian bars), £8 per subsequent bar. Olympian bars (Bronze, Silver or Gold) are £10, if a medal is required with the Olympian bar then the fee is £26.50. UK Medals are £20. Payment with orders please.

SHOW RULES, PROCEDURES AND REGULATIONS

This show is licensed by the Governing Council of the Cat Fancy and is open to all. Copies of the GCCF Rules are available from the GCCF Office, 5 King's Castle Business Park, The Drove, Bridgwater, Somerset TA6 4AG. Please make sure you read and understand these rules and the schedule before entering the show. **IGNORANCE OF ANY RULE WILL NOT BE ACCEPTED AS EXCUSE OF ITS BREACH**

Exhibits actually received into the show hall are received on condition that the Club shall not be responsible for any loss or damage to exhibits, boxes, baskets or in any other way and thereafter may not be removed before the Show closes without the permission of the Show Manager. Nobody may remove an exhibit from its pen except the owner, owner's representative or show official. Exhibitors may not carry their exhibits around the show hall or hold them in such a way as to upset other exhibits. Exhibitors must be within call throughout the period of the show, except during the time the hall is cleared for judging. The show closes at 5.00 pm, or earlier at the Show Manager's discretion, and no exhibit may be removed before this time. Failure to observe this rule may lead to disqualification and forfeiture of any prizes awarded.

Judging and Judges

Judging will commence at 10.00 am and exhibitors will be asked to clear the hall until 12.30 pm. Judges are empowered to withhold any prize, award or certificate in any class if an exhibit does not, in their opinion possess sufficient merit. Prizes will be awarded from the judges slip only. **THE JUDGE'S DECISION IS FINAL.** An exhibitor may not enter into any conversation with a judge until that judge's engagement is complete.

GCCF Titles

The title of Champion shall be granted to entire cats winning three Challenge Certificates, under three different judges. A GCCF Challenge Certificate will be offered for each Adult Open Class with Championship status. The title of Premier shall be granted to neutered cats under the same rules and conditions as for Champions.

The title of Grand Champion shall be granted to entire cats winning three Grand Challenge Certificates, under three different judges. To enter a Grand Challenge Class a cat must be a full Champion by the published closing date for the show. A GCCF Grand Challenge Certificate will be offered, with a Reserve in case of disqualification. A Champion may also enter its appropriate breed Open Class. The title of Grand Premier shall be granted to neutered cats under the same rules and conditions as for Grand Champions.

The title of Imperial Grand Champion shall be granted to entire cats winning five Imperial Grand Challenge Certificates, under five different judges. To enter an Imperial Grand Challenge Class a cat must be a full Grand Champion by the published closing date for the show, A GCCF Imperial Grand Challenge Certificate will be offered, with a Reserve in case of disqualification. A cat entered in the Imperial Grand Champion Class may also enter either its appropriate breed Open Class, or the Grand Champion Class, but not both. The title of Imperial Grand Premier shall be granted to neutered cats under the same rules and conditions as for Imperial Grand Champions.

Countersigning of Certificates

If your Open Class Judge is changed after the closing date of the show, and the replacement Judge has already awarded a Certificate to your cat, another Judge will be appointed to consider your cat for countersignature if it is awarded the Certificate, **PROVIDED YOU TELL THE SHOW MANAGER BEFORE JUDGING STARTS.** Countersigned Certificates count towards a title or qualification of Preliminary status breeds. If the replacement judge at this show has also been previously booked for a subsequent show, the closing date of which is before the date of this show, then at the subsequent show this judge can be considered as a replacement judge for the purpose of requesting a countersignature.

Correspondence

All correspondence must be accompanied by a S.A.E. if a reply is required. Any complaint related to the show must be forwarded to the Show Manager within 7 days of the show.
